Bateria

Desmontando

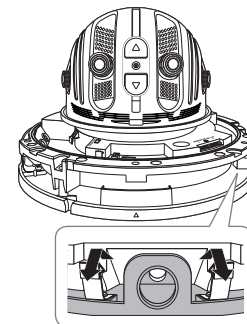

2. Desaperte o parafuso de fixação no corpo da câmera.

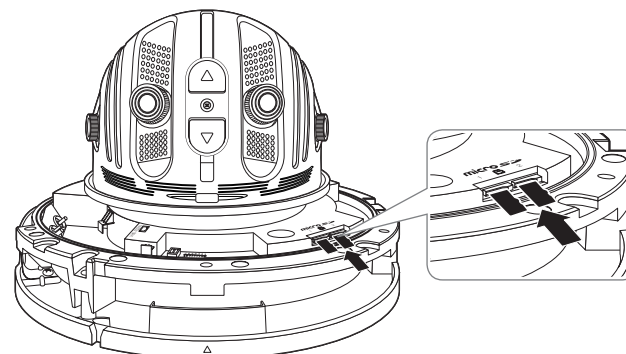


3. Remova o corpo da câmera e placa de montagem puxando a mola da placa, como mostra a imagem.



Inserindo um cartão de memória Micro SD

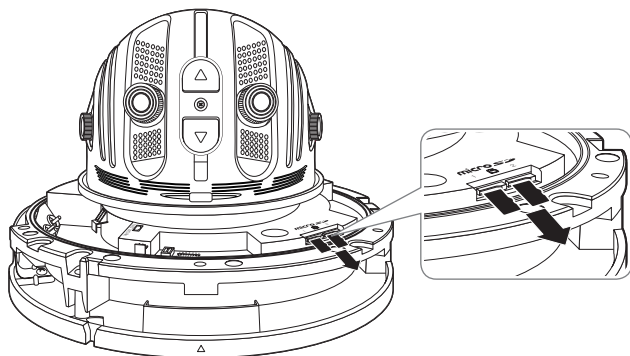
1. Remova a tampa superior da câmera.
2. Insira um cartão Micro SD na direção da seta mostrada na figura.



- ! ■ Desconecte o cabo de alimentação da câmera antes de inserir o cartão de memória Micro SD.

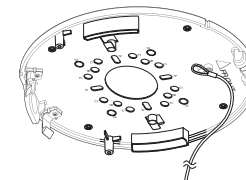

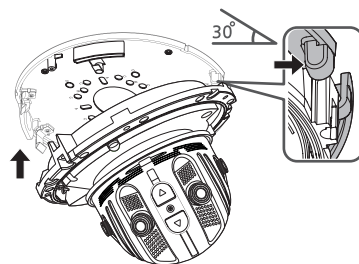

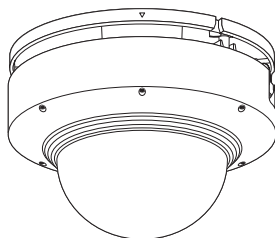

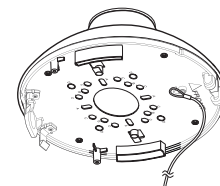

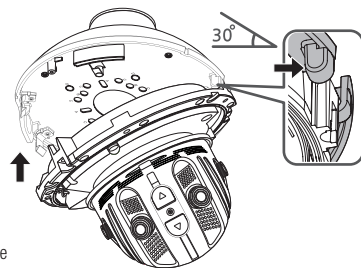

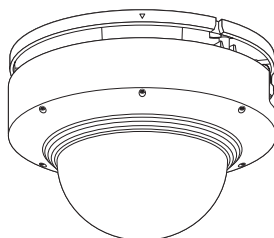

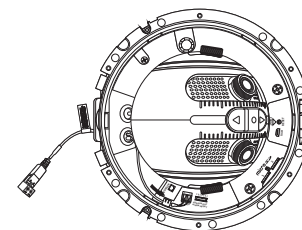

 - Câmera: use o cabo com um diâmetro de Ø5~6,5.
 - Componentes fornecidos: use o cabo com um diâmetro de Ø7~8,5.



3. Introduza o cabo de alimentação no orifício menor feito pela remoção da parte projetada do tampão de borracha na etapa 2 acima e coloque o cabo ao longo da ranhura.

4. Conecte o cabo de alimentação com o terminal do bloco de alimentação.

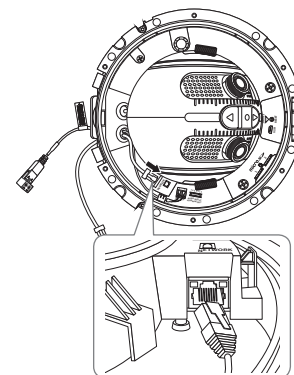


5. Introduza o cabo LAN (rede local) no orifício maior feito pela remoção da parte projetada do tampão de borracha na etapa 2 acima, e coloque o cabo ao longo da ranhura.

6. Remova a bainha com um cortador de cabos, e alinhe os cabos.

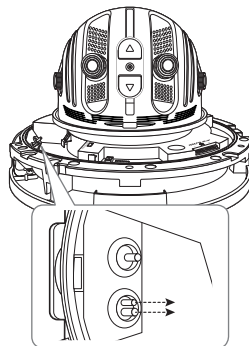
7. Conecte o cabo LAN com um conector LAN e introduza-o na ferramenta LAN.

8. Conecte o cabo acabado porta de Ethernet.

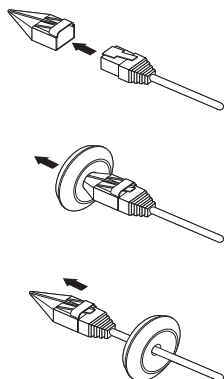


Método 2. Conectar o cabo de alimentação à prova d'água e o cabo LAN

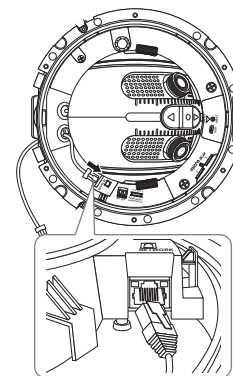
1. Remova a tampa do dome e a caixa.

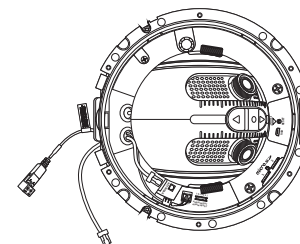
4. Use o instalador de tampa para permitir que o cabo RJ45 passe pelo furo.



5. Insira a rolha de borracha de novo e conecte o cabo LAN ao terminal Ethernet.

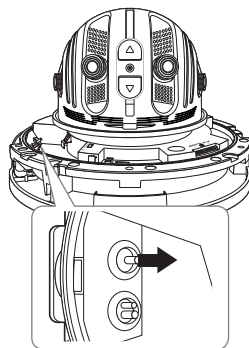

7. Conecte o cabo de alimentação com o terminal do bloco de alimentação.

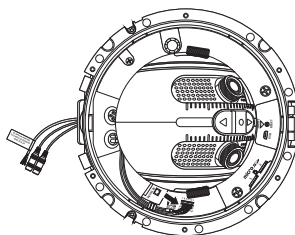


Ligando o cabo de áudio/alarme

1. Remova a tampa do dome e a caixa.
2. Puxe a parte longa projetada do tampão de borracha na parte inferior e retire-o conforme apresentado na figura.



3. Insira o cabo de áudio/alarme no orifício criado ao remover o tampão de borracha no passo 2, e conecte o cabo com o terminal de alarme PCB.
4. Alinhe o cabo de forma a não ficar danificado ou obstruído ao instalar a câmera.
5. Coloque a tampa de borracha do cabo de áudio/alarme no orifício.
6. Ajuste a lente em uma direção desejada consultando a seção **"Ajustando a direção de monitoramento da câmera"**. (Página 15)
7. Fixe a tampa do dome.



Instalação do adaptador de suporte opcional

Escolha e compre um dos seguintes opcionais necessários (não fornecidos) adequado ao site de instalação ou para sua conveniência.

1. Remova a tampa do dome da caixa, consultando a seção **"Desmontando"**. (Página 9)
2. Fixe a caixa da câmera ao adaptador de suporte opcional usando os parafusos de máquina fornecidos com a câmera.
3. Conecte e organize os cabos necessários para que não sejam danificados ou torcidos durante a instalação da câmera.
4. Instale o corpo da câmera na ordem inversa de **"Desmontando"**.
5. Ajuste a lente em uma direção desejada consultando a seção **"Ajustando a direção de monitoramento da câmera"**. (Página 15)
6. Feche a tampa do dome.
 - Para garantir que não surjam problemas com a impermeabilização, aperte os parafusos de fixação firmemente usando a chave Allen ou broca.

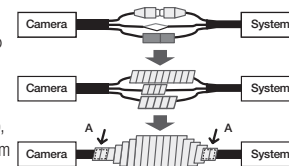
Instalação no exterior

Quando instalar o aparelho, se o fizer fora do edifício, por favor impermeabilize a ficha com tape impermeável de borracha butílica (pode ser adquirida em lojas) para que a água não extravase a partir do vão do cabo conectado para o exterior.

1. Conecte a alimentação, I/O, e os cabos LAN.
2. Envolve o revestimento do cabo negro (Área A) e a área de ligação do cabo com tape impermeável (borracha butílica) de modo que mais de metade da fita de borracha de butilo esteja sobreposta.



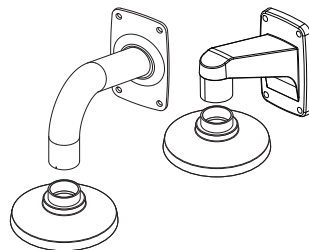
- Se o invólucro do cabo não se encontrar adequadamente impermeabilizado, pode diretamente provocar vazamento. Certifique-se de proteger o cabo com uma densa camada de tape.
- A tape de borracha butílica é fabricada a partir de borracha de butilo que pode ser esticada até ao dobro de seu comprimento normal.



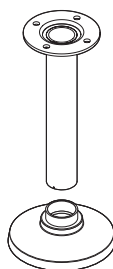

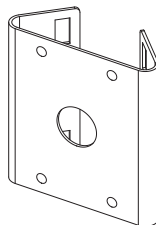

É um adaptador de suporte que é usado para instalar a câmera dome na parede.



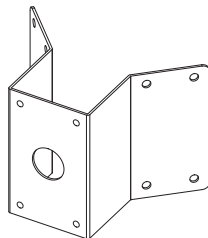

Diagrama Elétrico de Alarme Ligado

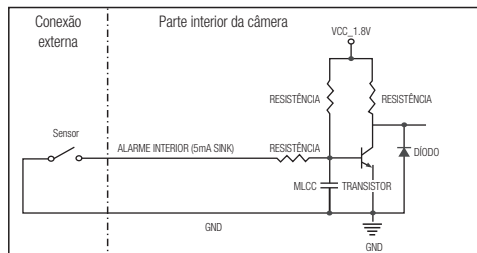
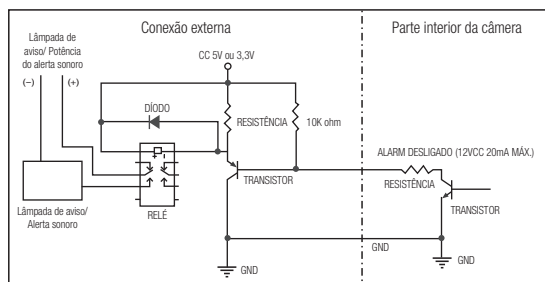


Diagrama Elétrico de Alarme Desligado

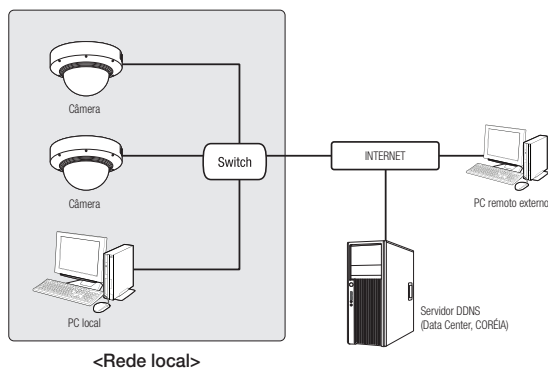

Everyone is permitted to copy and distribute verbatim copies of this license document, but changing it is not allowed.

Preamble

The GNU General Public License is a free, copyleft license for software and other kinds of works. The licenses for most software and other practical works are designed to take away your freedom to share and change the works. By contrast, the GNU General Public License is intended to guarantee your freedom to share and change all versions of a program—to make sure it remains free software for all its users.

We, the Free Software Foundation, use the GNU General Public License for most of our software; it applies also to any other work released this way by its authors.

TERMS AND CONDITIONS

0. Definitions.

"This License" refers to version 3 of the GNU General Public License.
