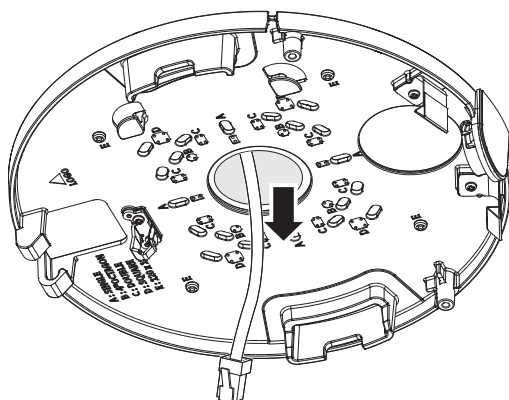


6-1 • Direkte Montage an der Wand/Decke



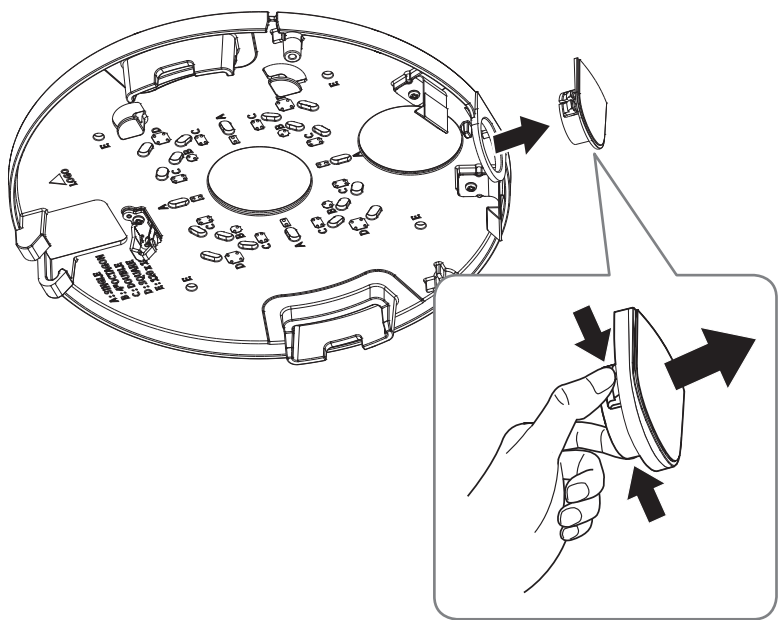

• Anschluss der Alarm-/Audiokabel



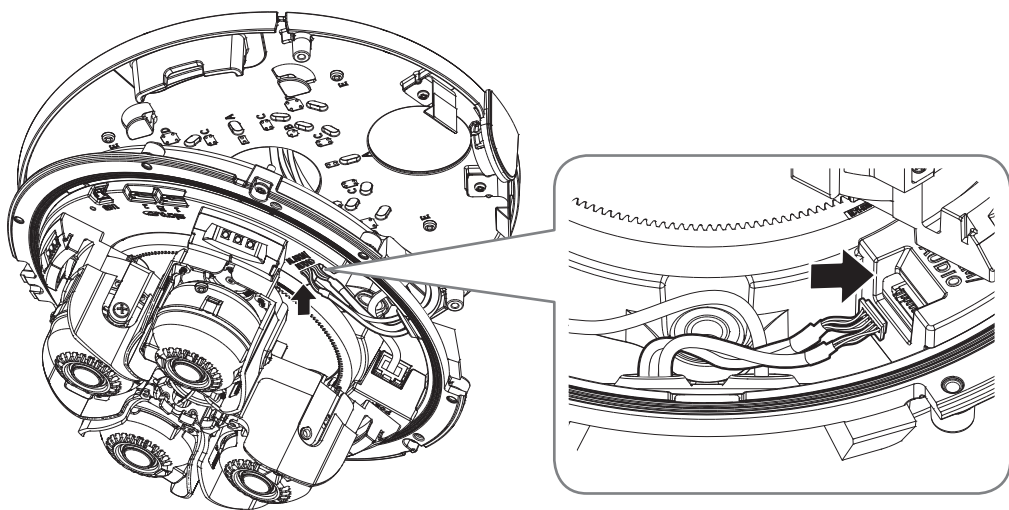
