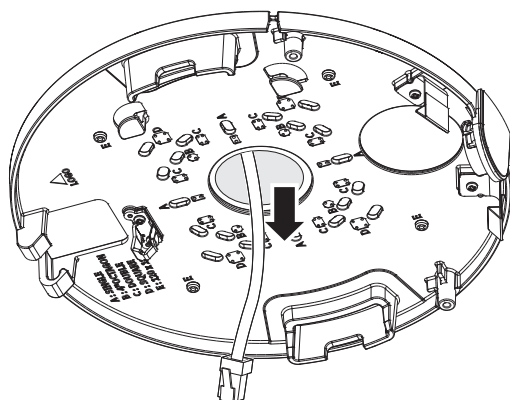


6-1 • Instalación directa en muro/techo



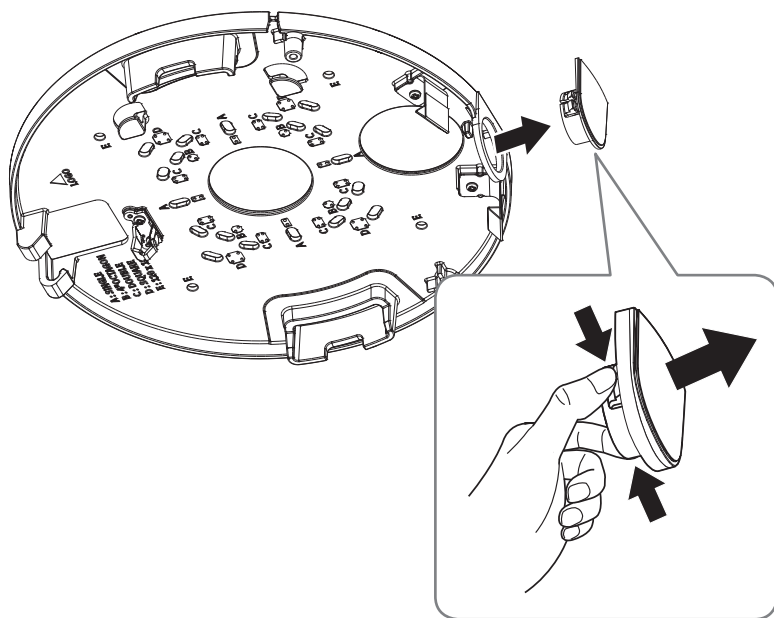

CONFIGURACIÓN DE CONTRASEÑA

Al acceder al producto por primera vez, debe registrar la contraseña de inicio de sesión.

- 1 Conecte el adaptador OTG (5 pines) y el dongle WiFi al terminal micro USB.

Configuración del teléfono inteligente

- 1 Instale la aplicación de instalación de Wisenet.
- 2 Seleccione el SSID de la cámara después de encender el WiFi.
- 3 Ejecute la aplicación de instalación de Wisenet.
- 4 Cuando inicie sesión en la cámara, se conectará el vídeo.
 - El vídeo se reproducirá sin estar conectado durante la conexión inicial.
- 5 Puede ajustar el ángulo de visión mientras ve el vídeo a través del smartphone.
