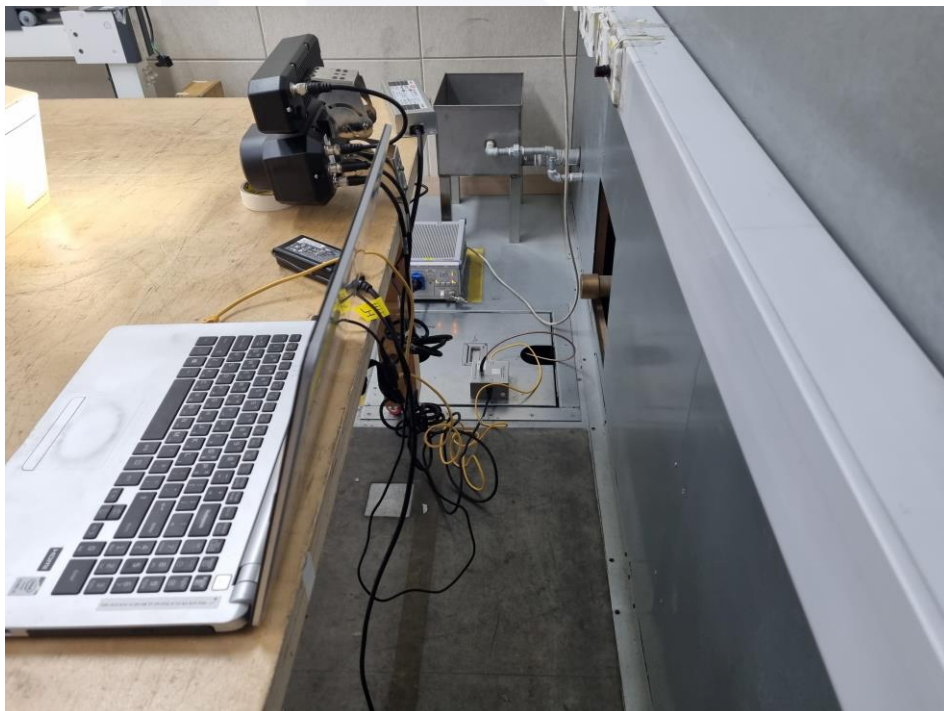

Conducted Emissions at Mains Power Ports



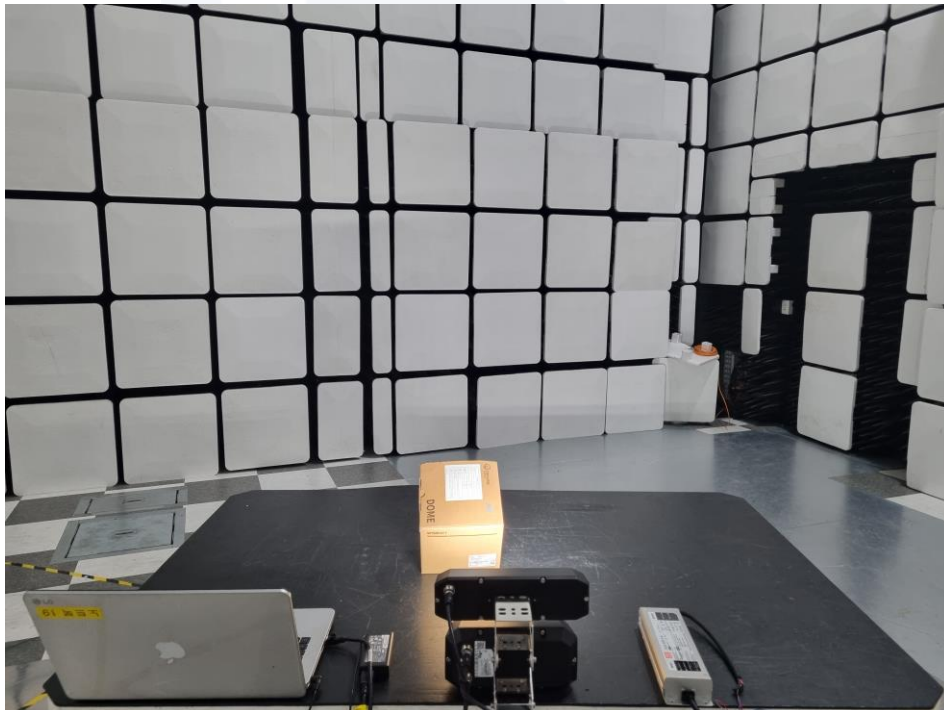
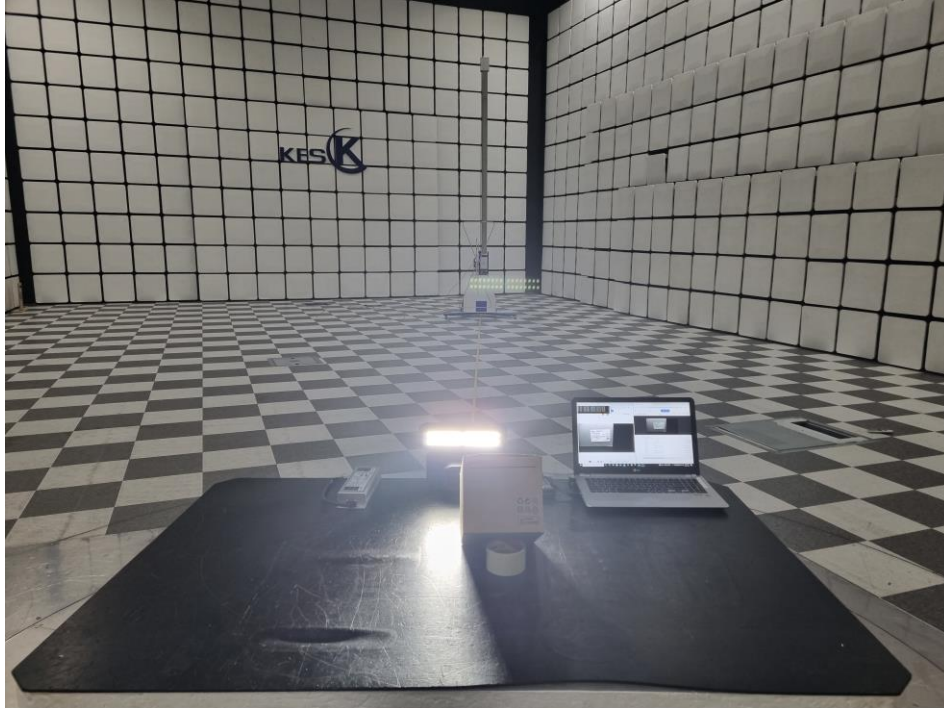


Conducted Emissions at Telecommunication Ports

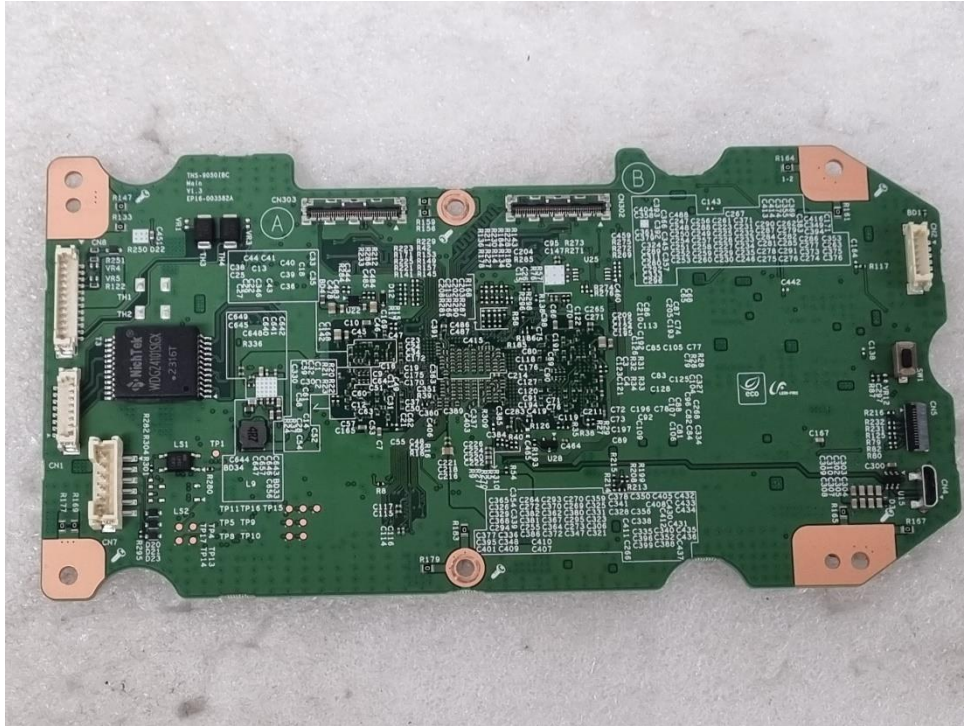

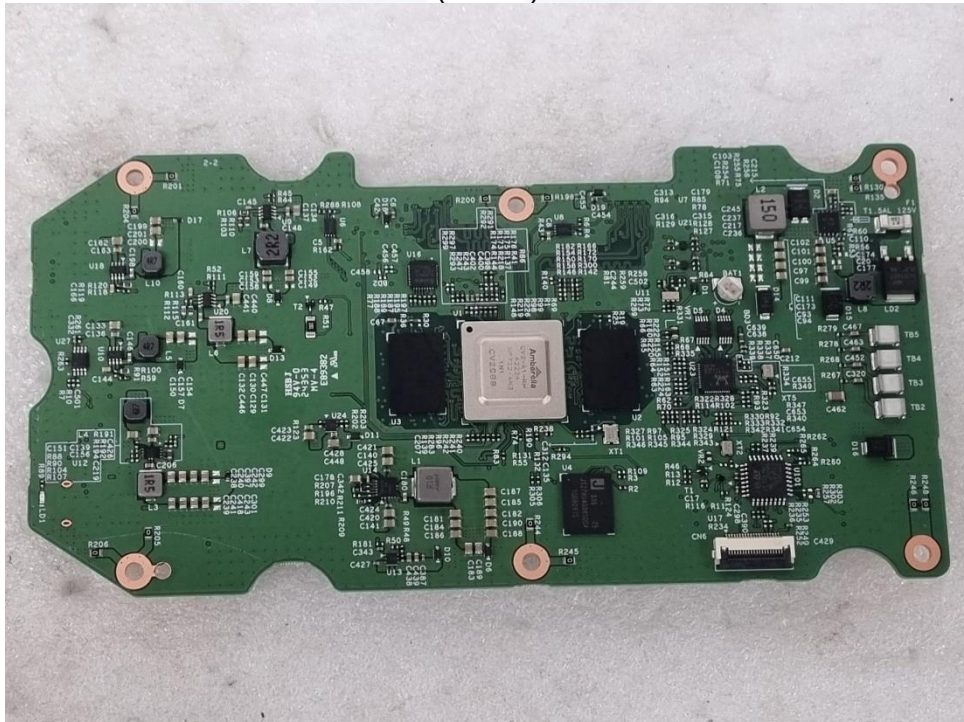

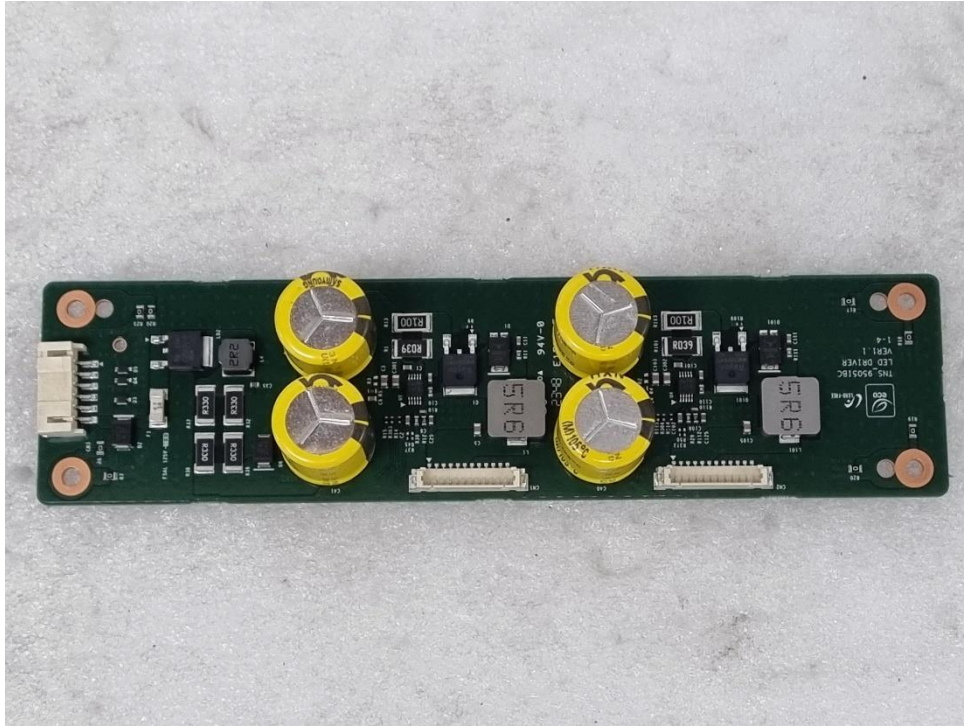

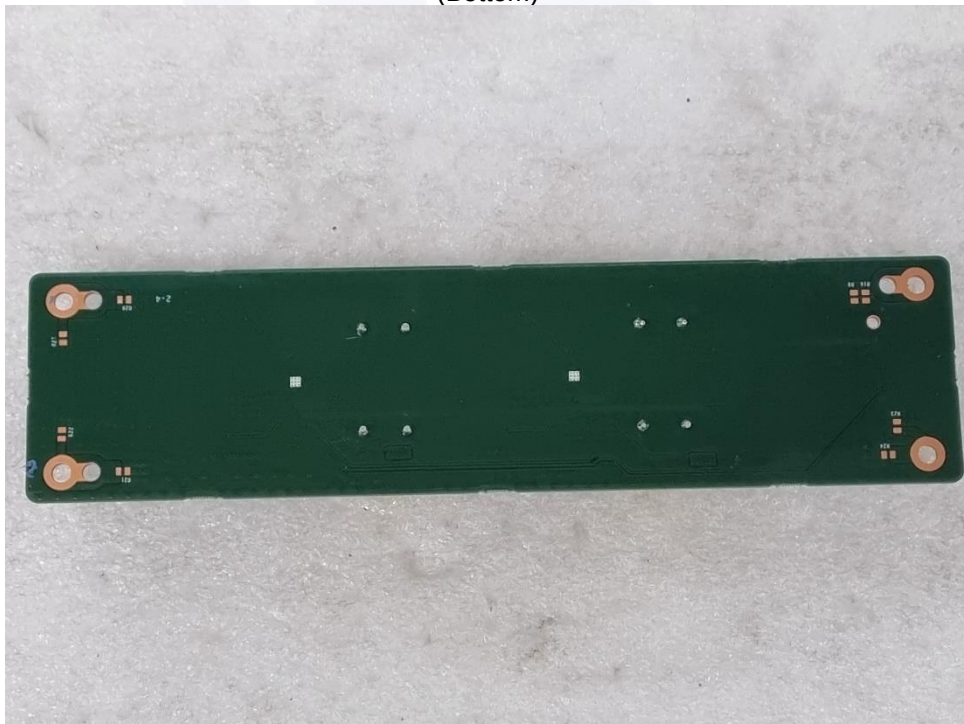

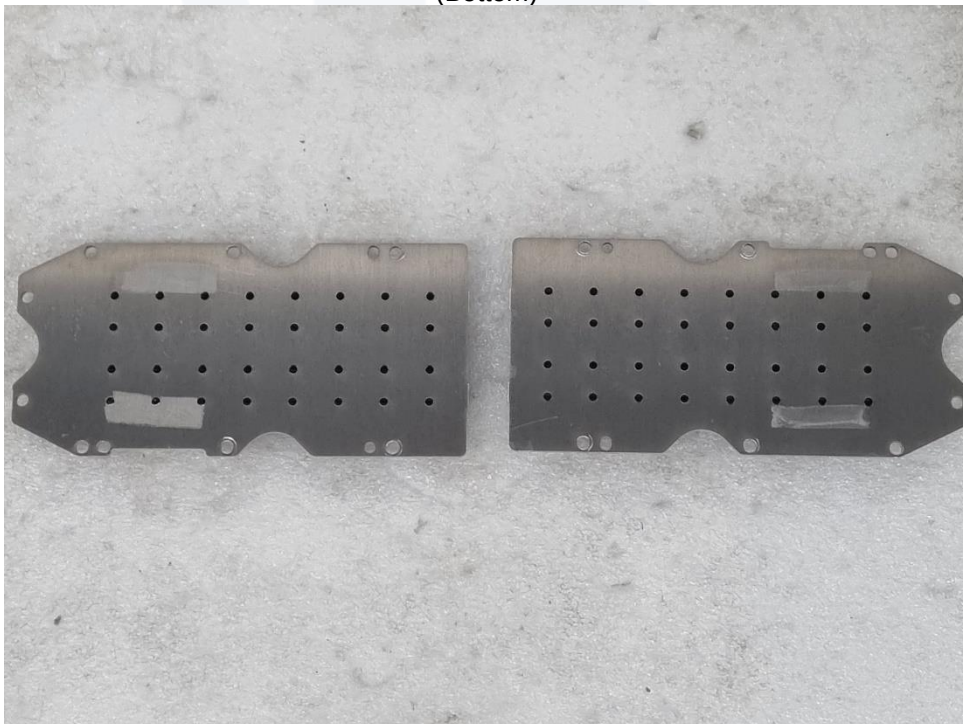


EUT Internal View – LED Board

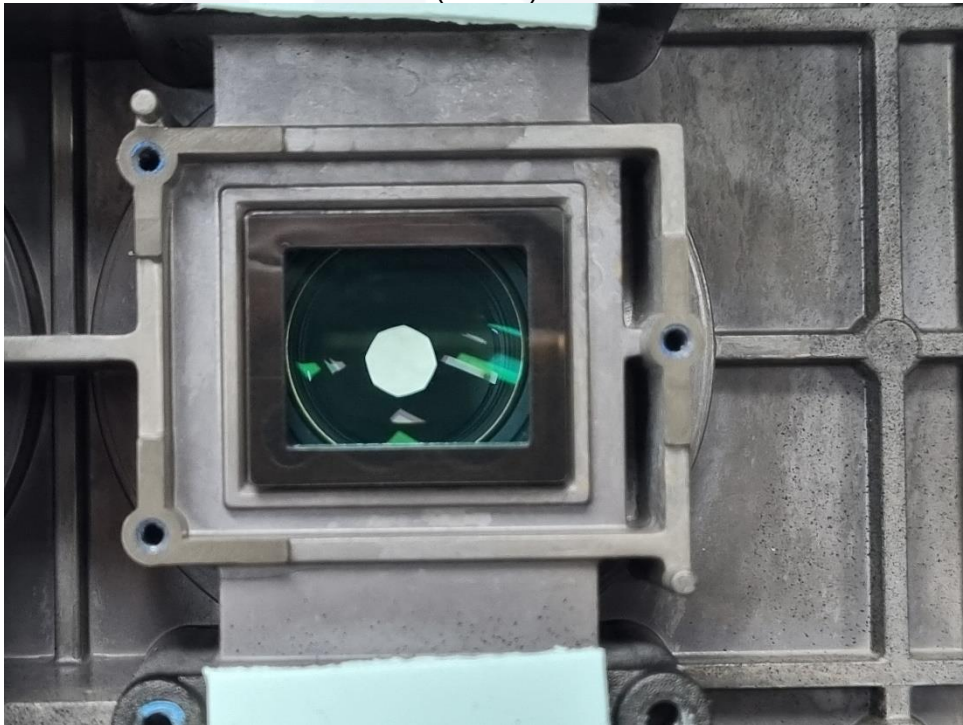
