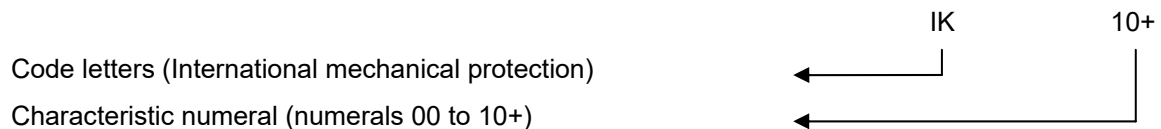

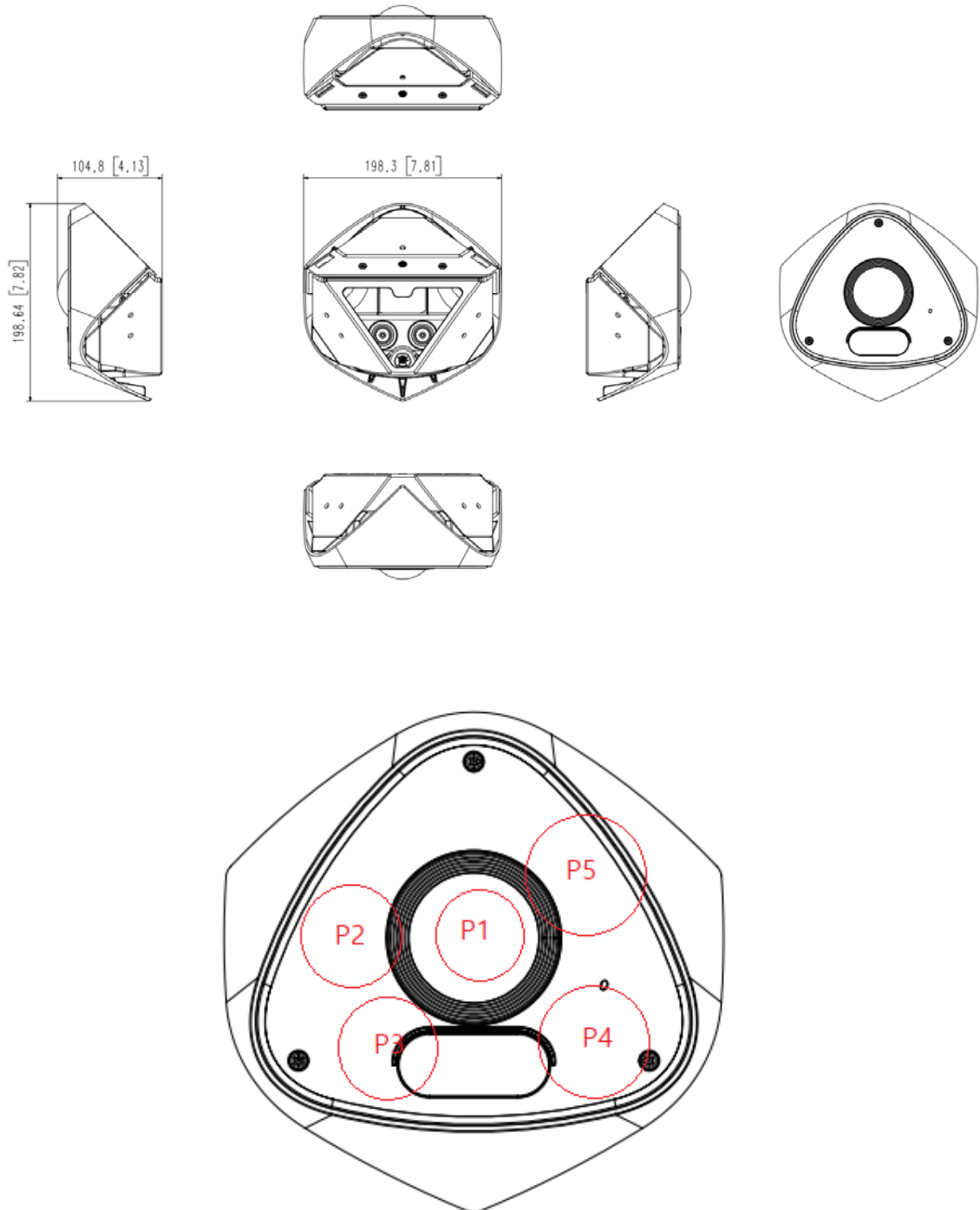

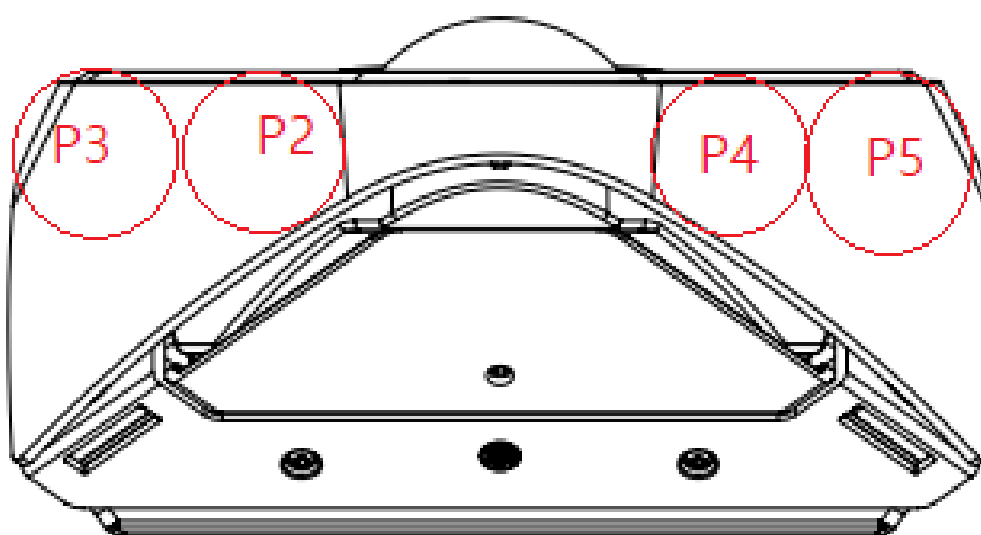
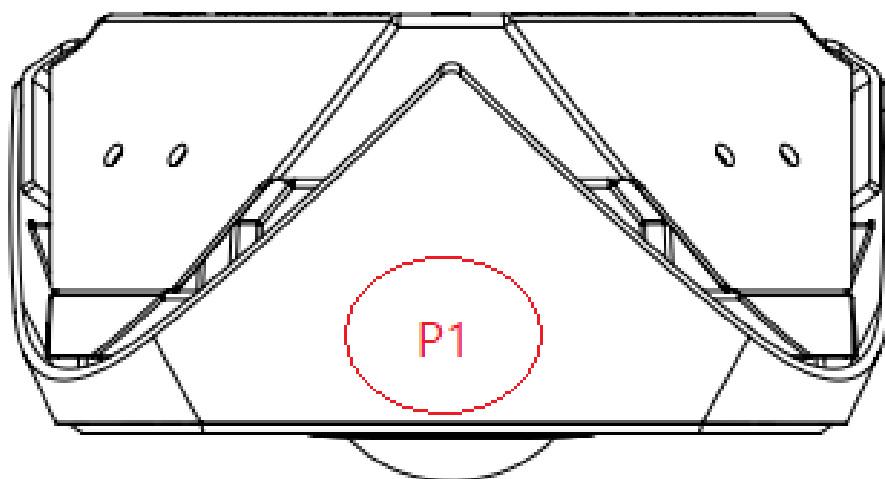
2.4. Enclosure Dimensions or Impact point (Unit: mm)
