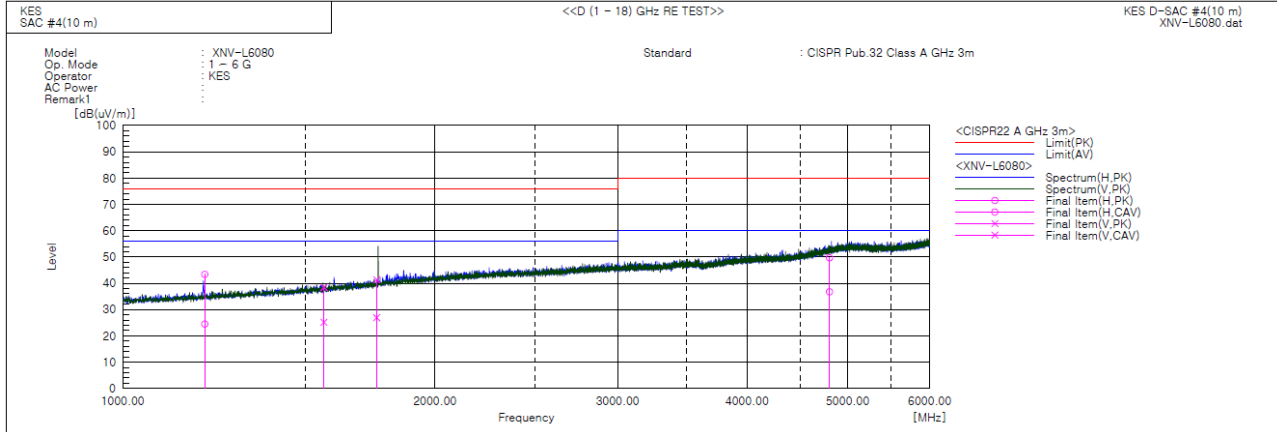

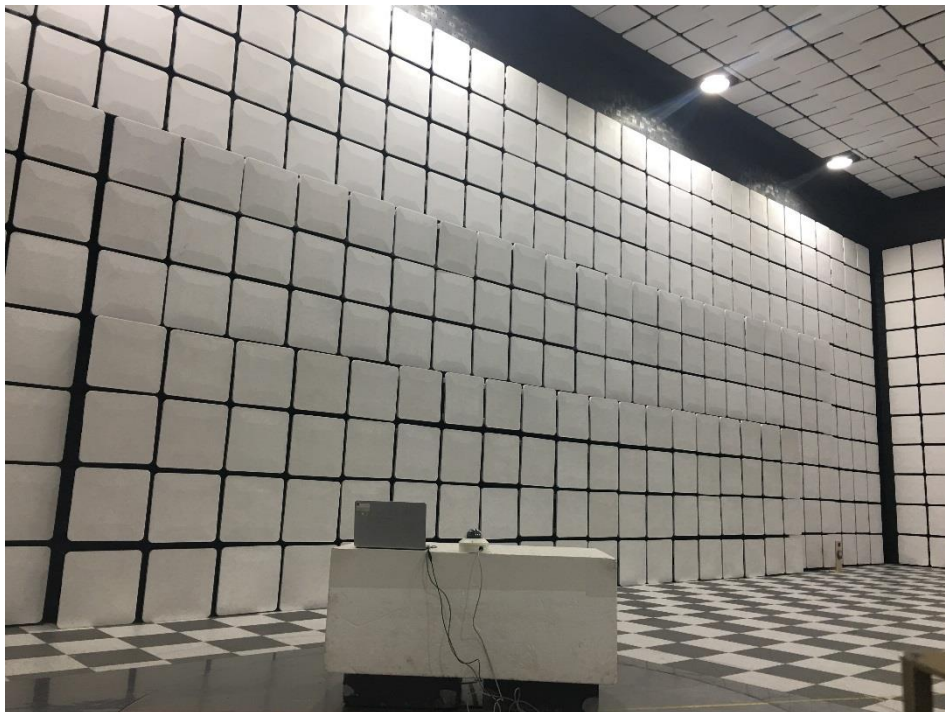

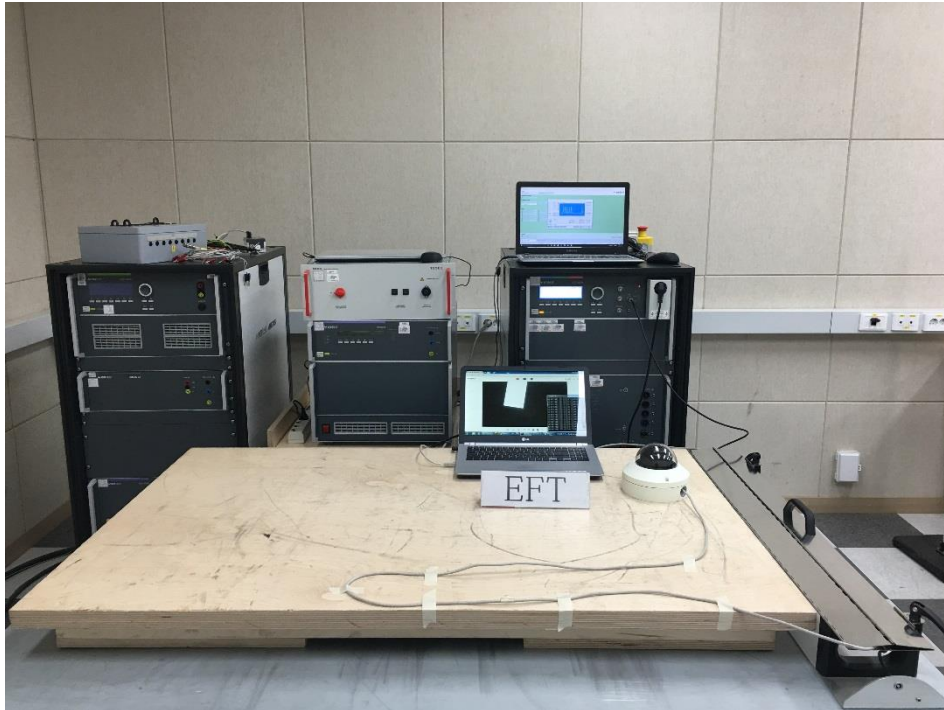


Radiated Electric Field Immunity
