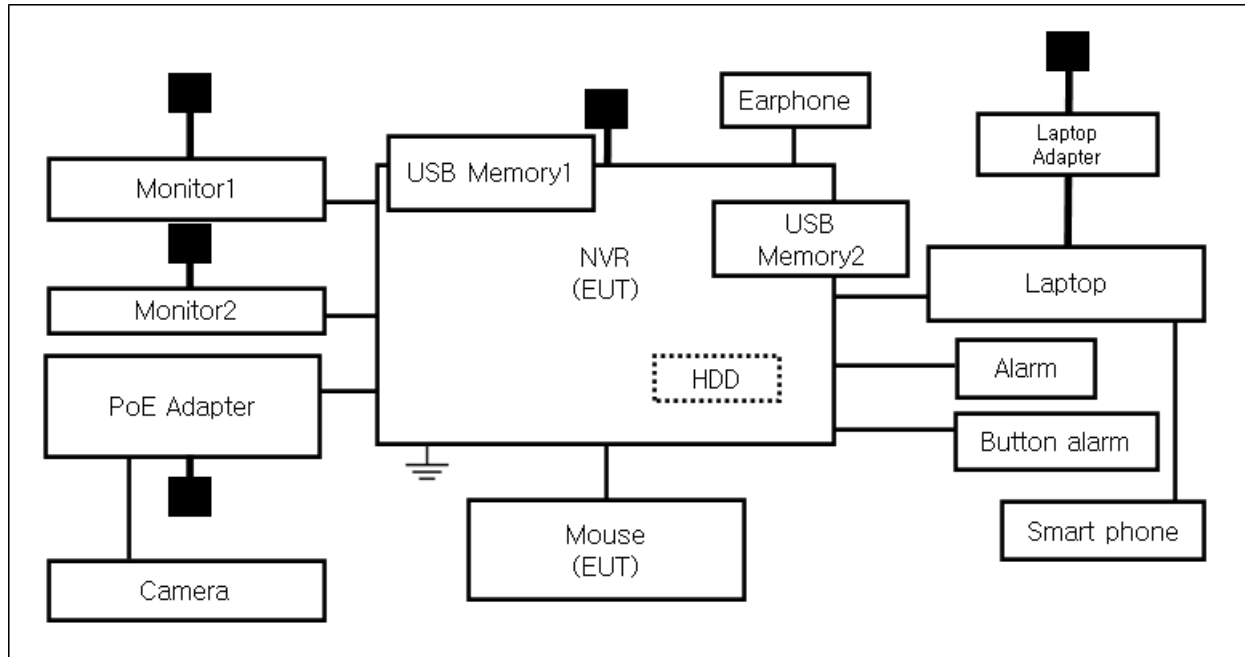

3.0 Criteria for compliance

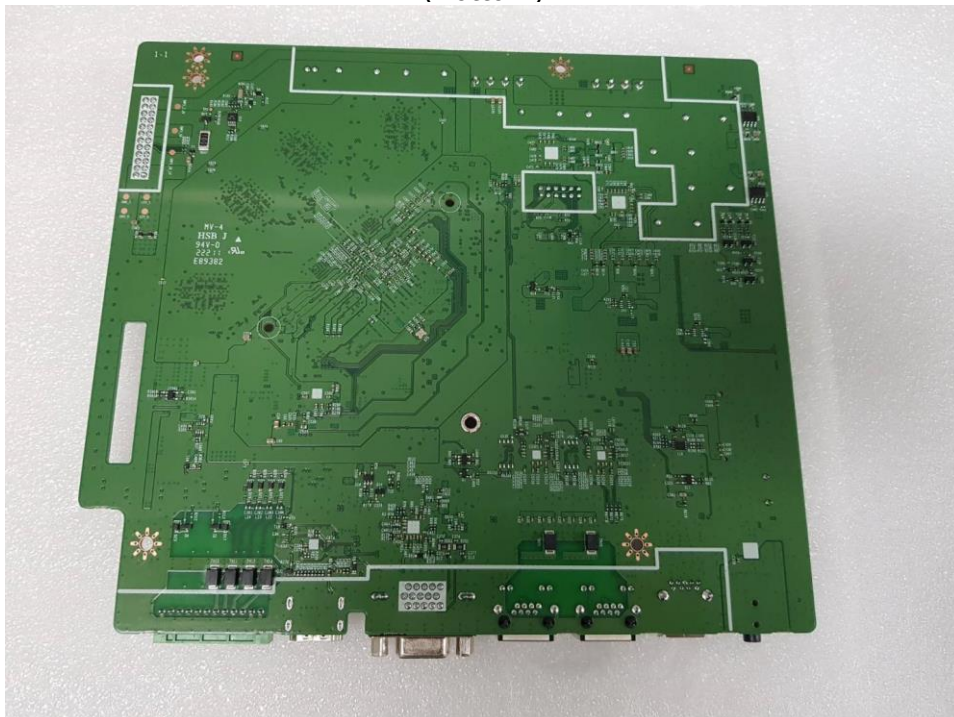


EUT Internal View – Main Board

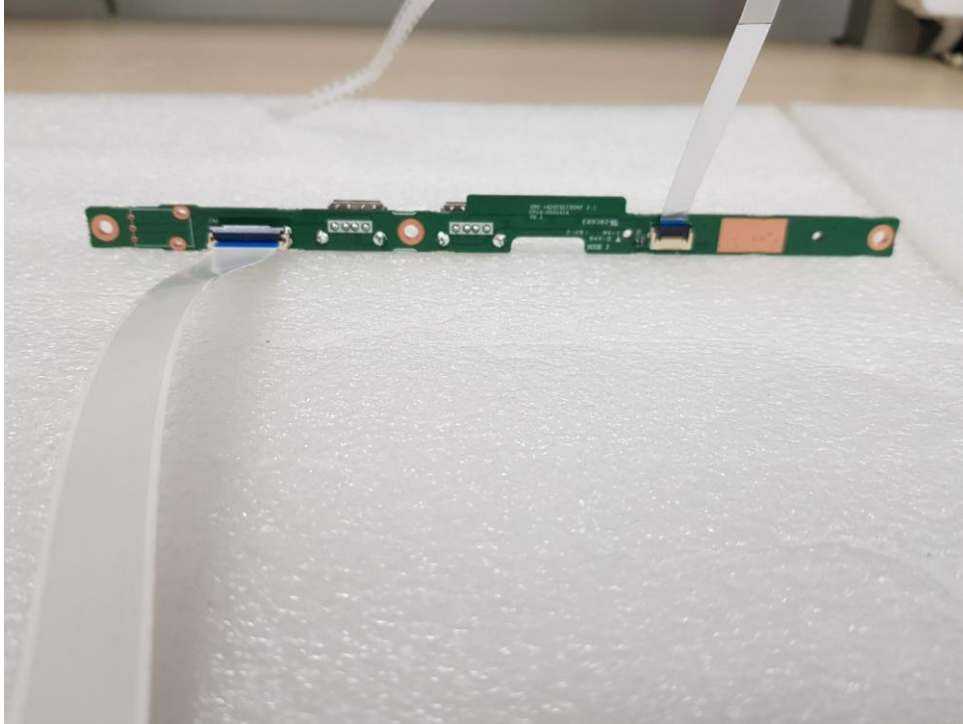

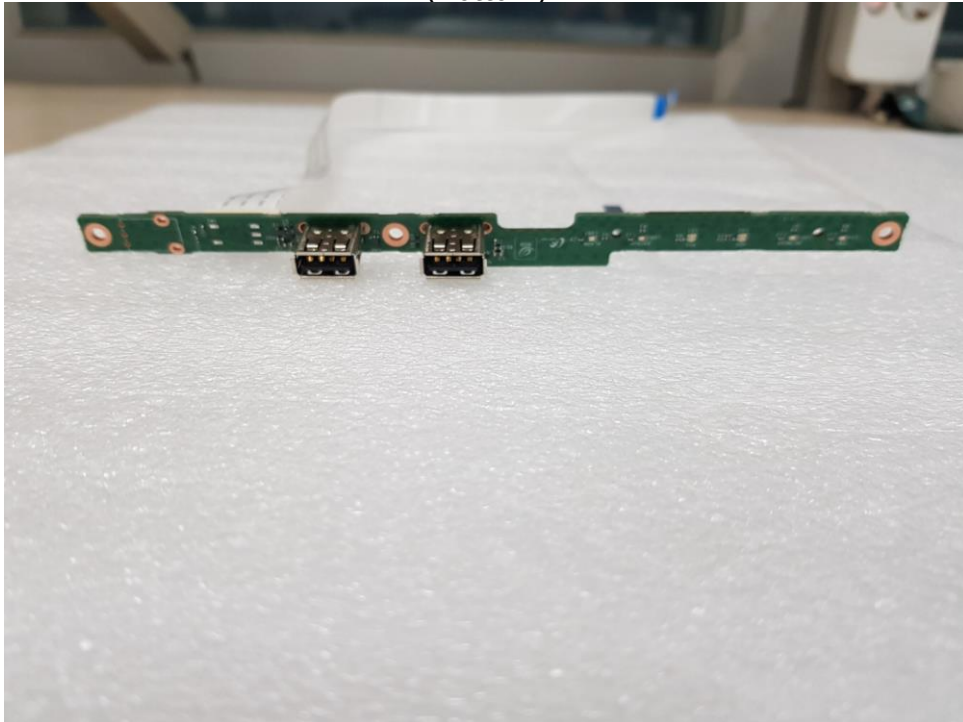

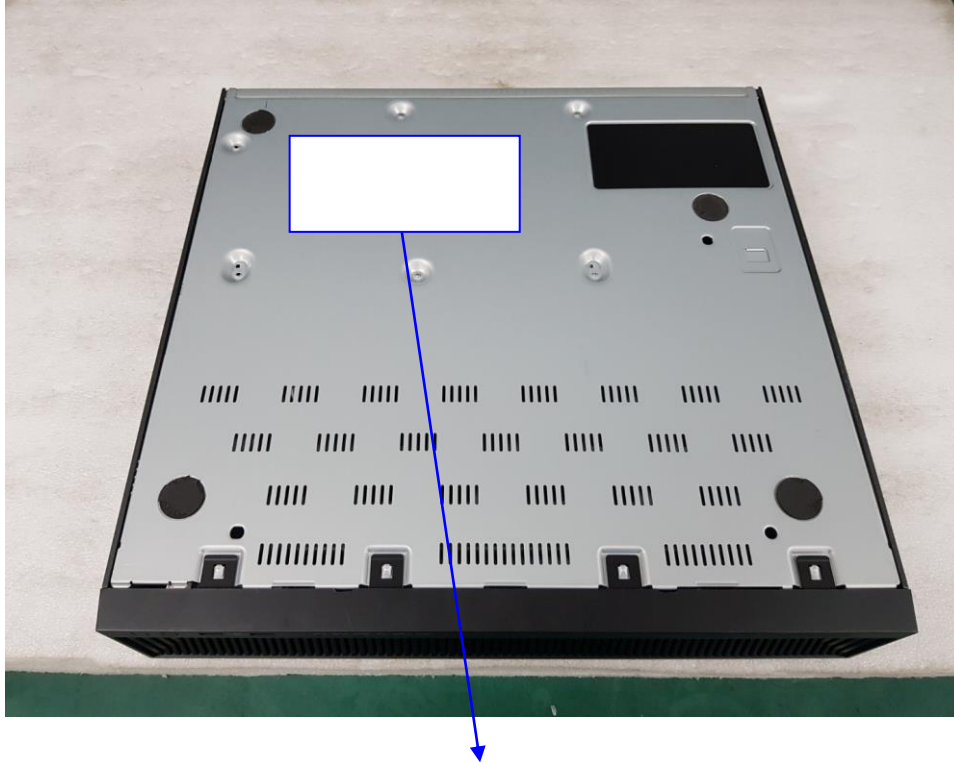
