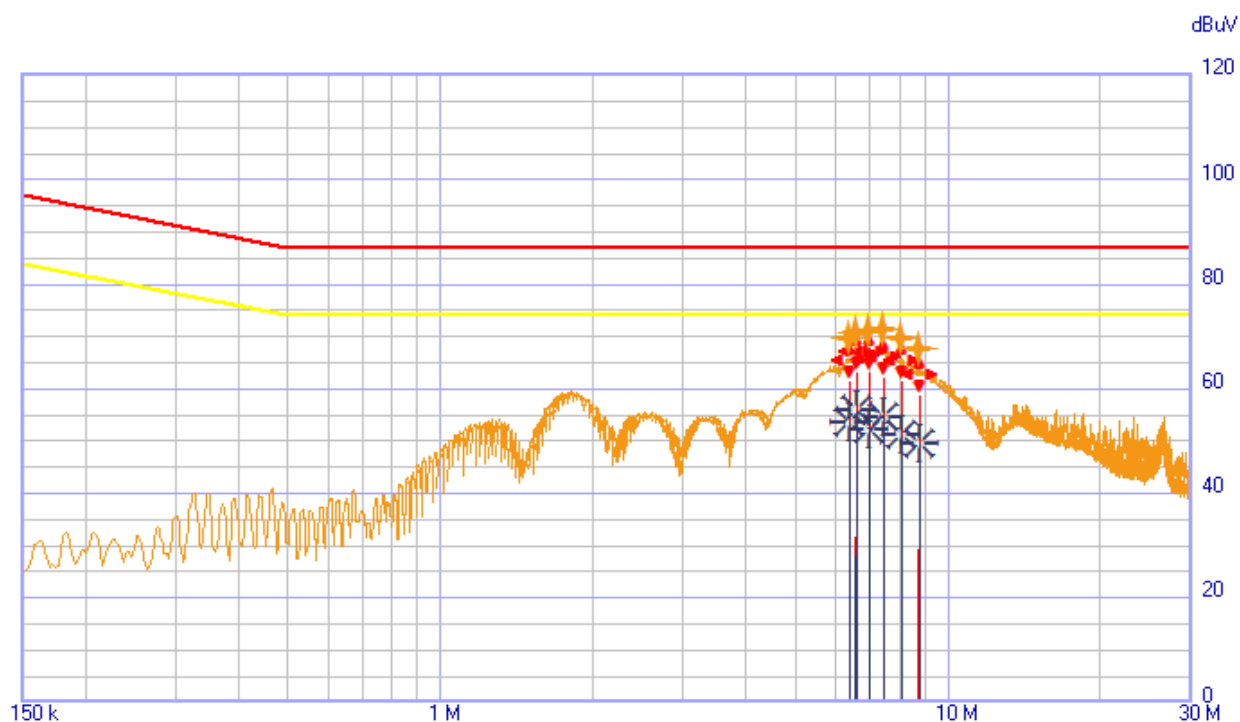

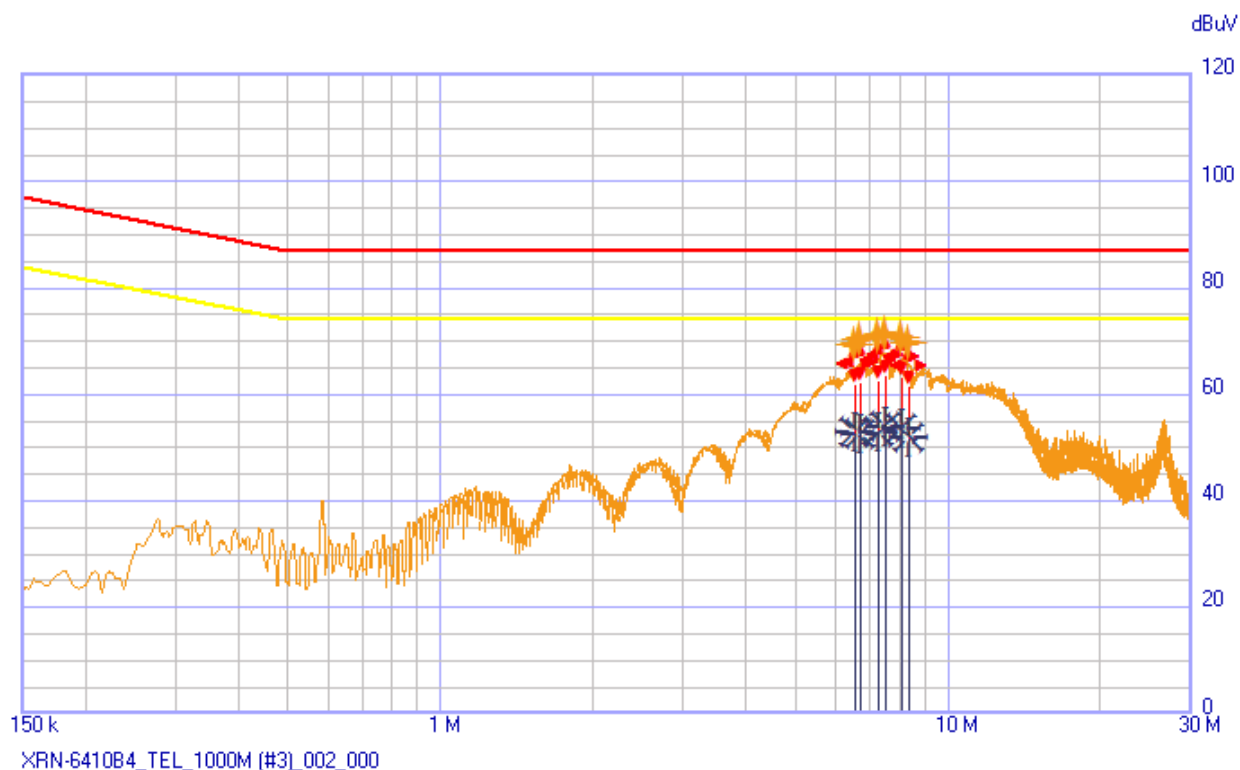

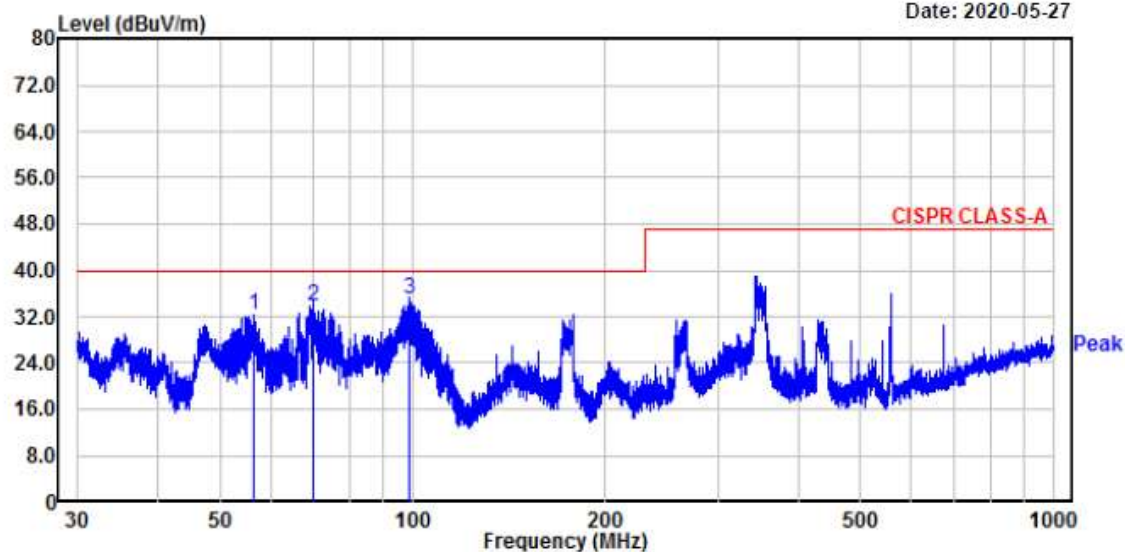

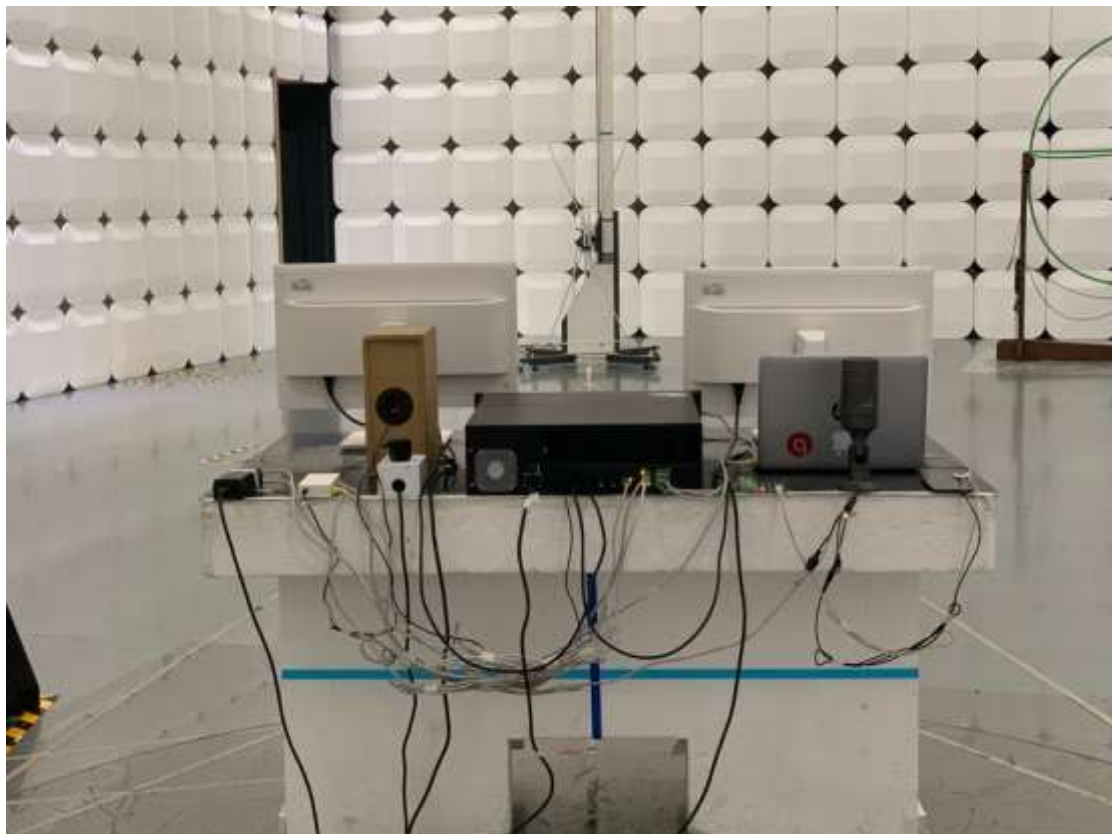
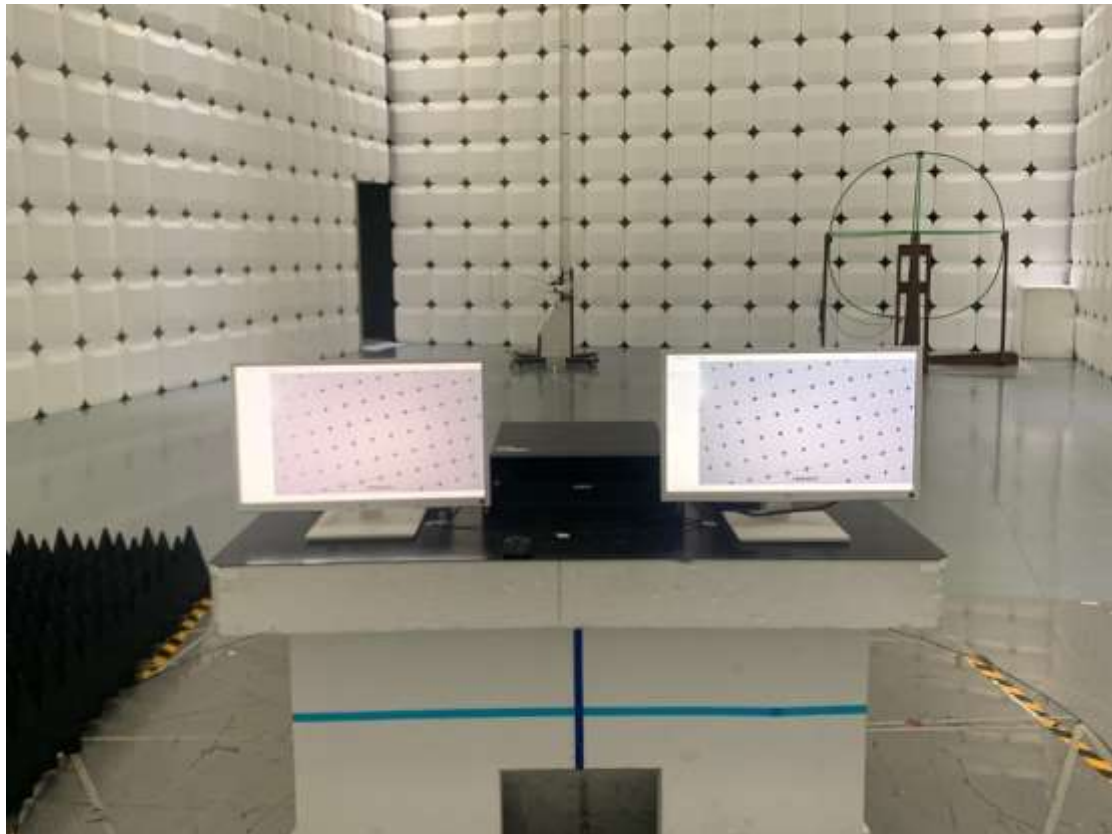

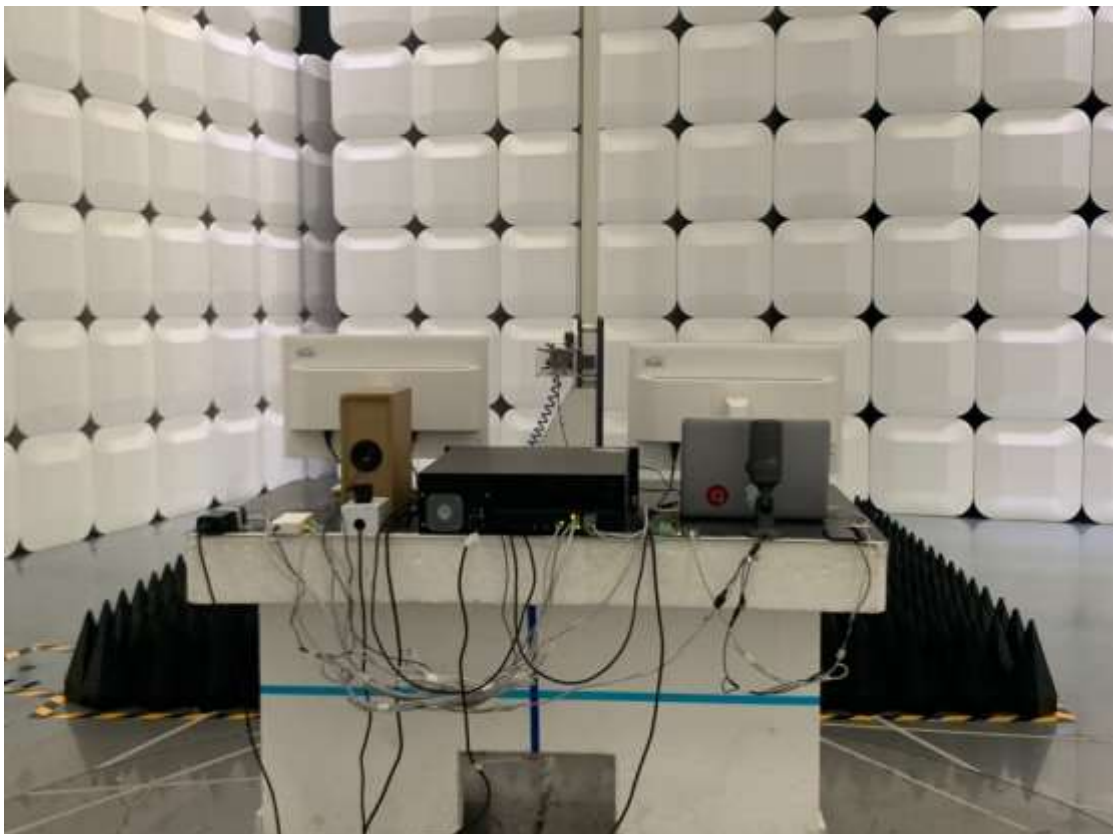
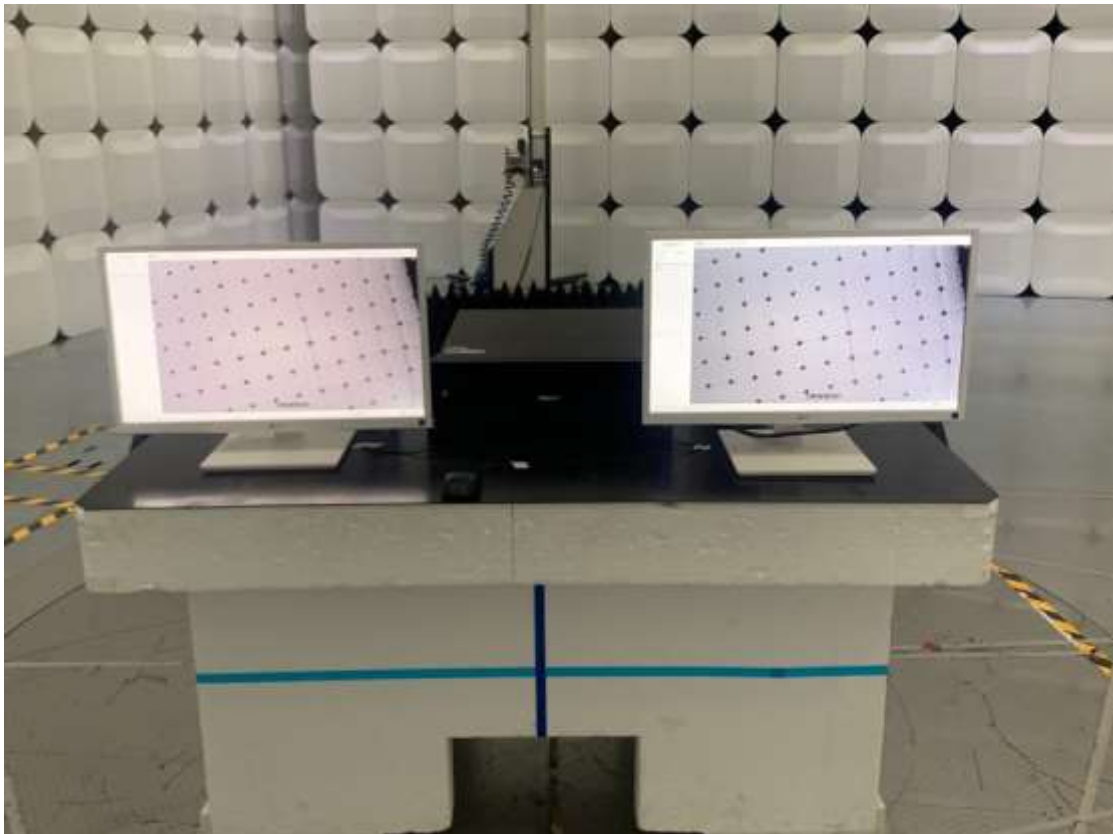
Conducted Emissions (TEL)
