RÉGLAGE DU MOT DE PASSE

Configuration du smartphone

- 1 Installez l'application d'installation Wisenet.
- 2 Sélectionnez le SSID de la caméra après avoir allumé le WiFi.
- 3 Exécutez l'application d'installation de Wisenet.
- 4 Lorsque vous vous connectez à la caméra, la vidéo sera connectée.
 - La vidéo sera lue sans être connecté pendant la connexion initiale.
- 5 Vous pouvez ajuster l'angle de vue pendant le visionnement de la vidéo via votre smartphone.
