1.1 Introduction

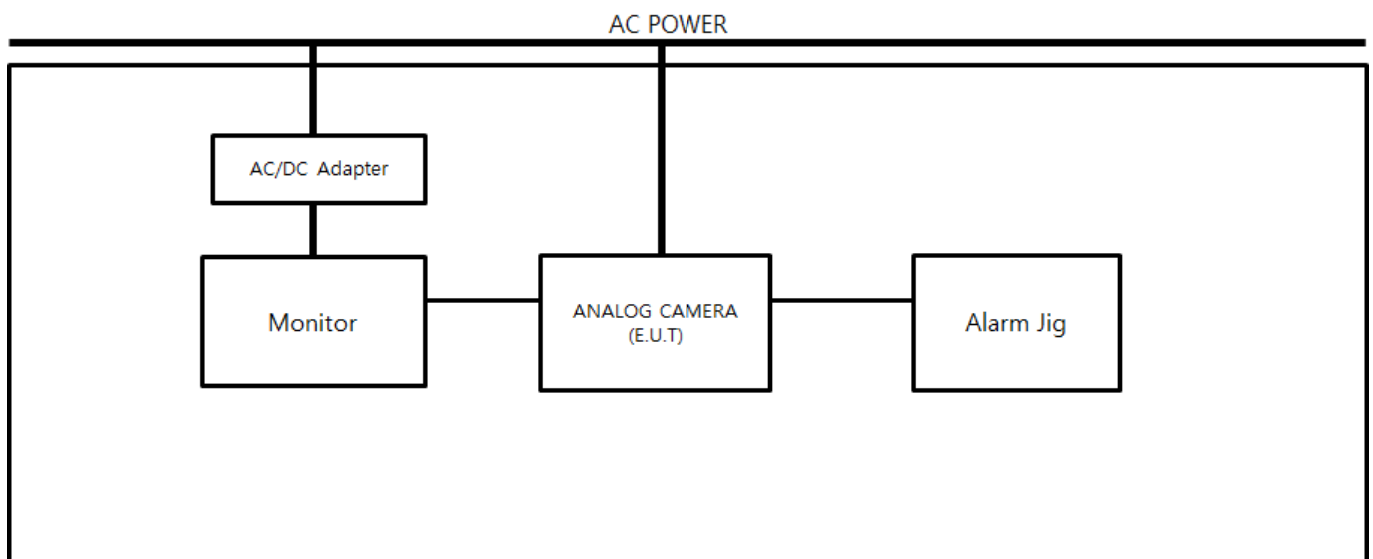

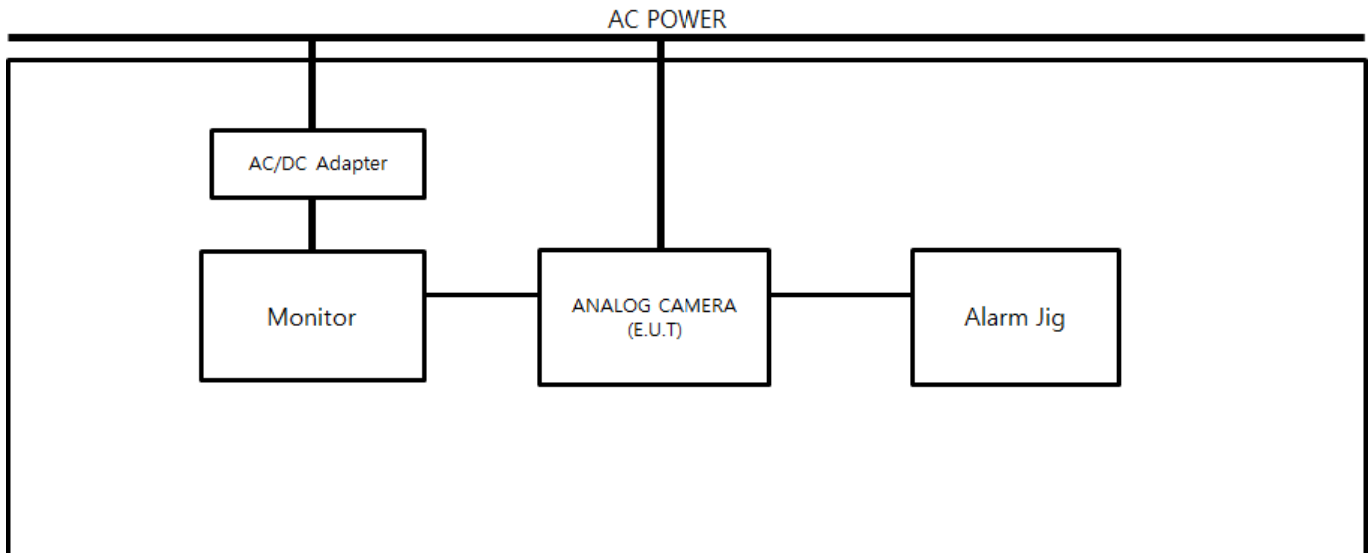

3. Test Performed

3.1 Conducted Emission Measurements

3.1.1 Test Description

The power line conducted emission measurements were performed in a shielded enclosure. The EUT was placed on a wooden table, 80 centimeters height above the floor. Power was fed to the EUT through a 50 ohm/ 50 micro henry Line Impedance Stabilization Network (LISN). The ground plane that was electrically bonded to the shield room ground system and all power lines entering the shield room were filtered.

3.1.5 Test Procedure

The conducted emission levels were measured on each current-carrying line with the spectrum analyzer operating in the CISPR quasi-peak mode (or peak mode if applicable). The analyzer's 6 dB bandwidth was set to 9 kHz. The initial step in collecting conducted data is a spectrum analyzer peak scan of the measurement range. If the conducted emission exceed the average limit with the instrument set to the quasi-peak mode, the measurements are made in the average mode. The emission spectrum was scanned from 150 kHz to 30 MHz. The highest emission amplitudes relative to the appropriate limits were measured and have been recorded. Quasi-peak readings are distinguished with a "QP".

The conducted emission test was performed with the EUT exercise program loaded, and the emissions were scanned between 150 kHz to 30 MHz on the HOT side and NEUTRAL side, herein referred to as H and N, respectively.

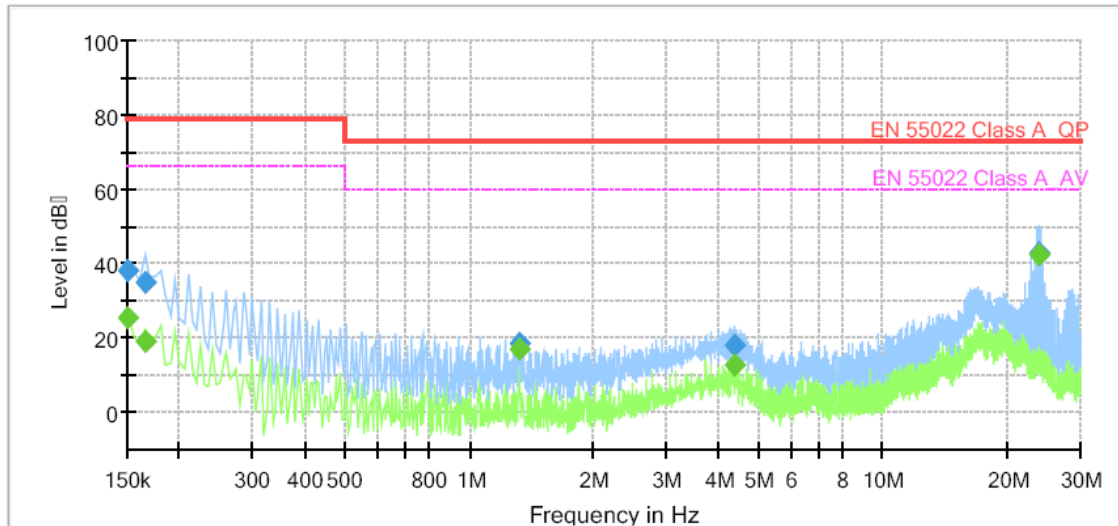

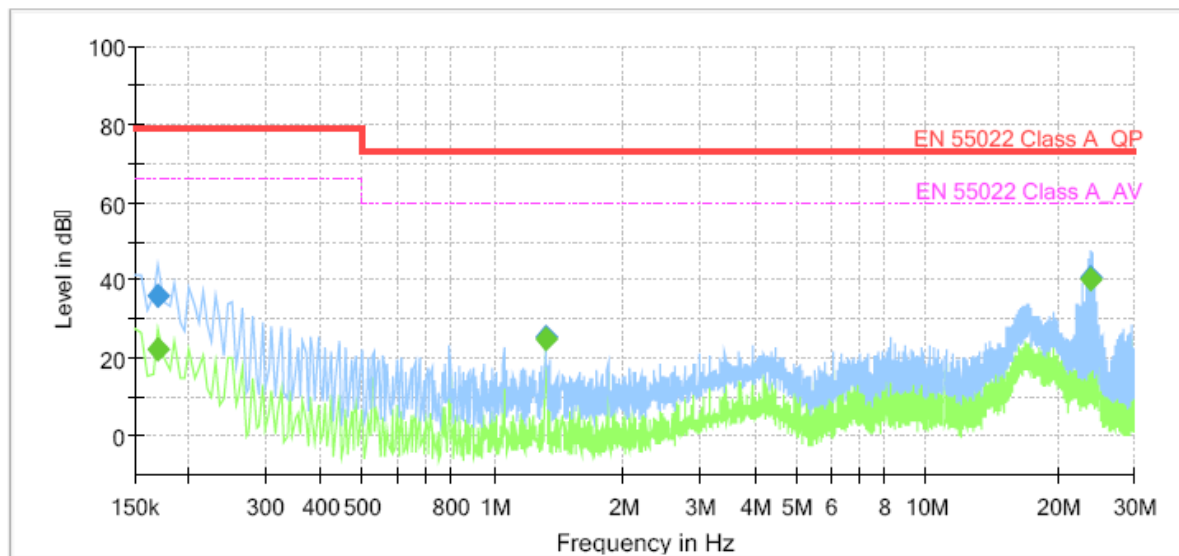

3.2 Radiated Emission Measurements

3.2.1 Test Description

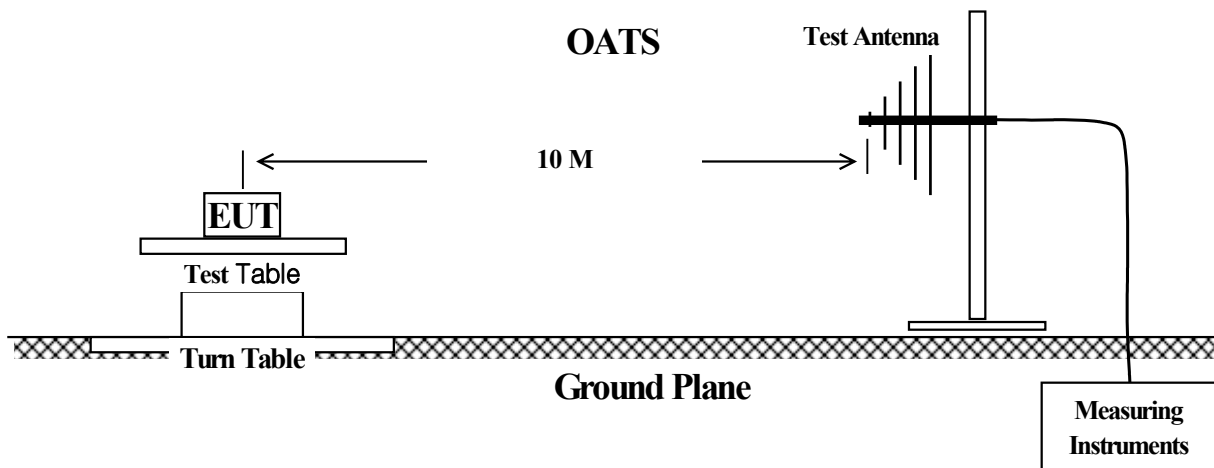
The radiated emissions measurements were performed on the ten-meter, open-field test site. The EUT was placed on a nonconductive turntable approximately 0.8 meters above the ground plane.

The frequency spectrum from 30 MHz to 1 000 MHz and 1 000 MHz to 6 000 MHz was scanned and maximum emission levels at each frequency recorded.

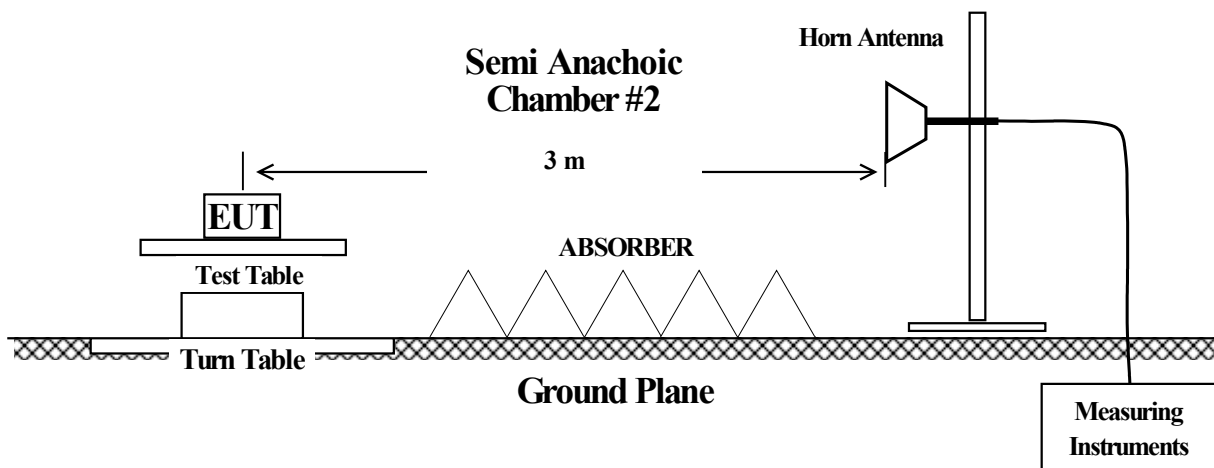
The system was rotated 360°, and the antenna was varied in the height between 1.0 and 4.0 meters in order to determine the maximum emission levels. This procedure was performed for horizontal and vertical polarization of the receiving antenna.

3.2.5 Test Procedure

Before final measurements of radiated emission were made on the OATS, the EUT was scanned in semi-anechoic chamber in order to determine its emission spectrum signature. The physical arrangement of the test system and associated cabling was varied in order to determine the effect on the EUT's emission in amplitude, direction and frequency. This process was repeated during final radiated emission measurements on the OATS range, at each frequency, in order to ensure that maximum emissions amplitudes were attained.

The radiated emission test was performed with EUT exercise program loaded, and the emissions were scanned between 30 MHz to 1 000 MHz and 1 000 MHz to 6 000 MHz using the spectrum analyzer. The spectrum analyzer's 6 dB bandwidth was set to 120 kHz(1 MHz), and the analyzer was operated in the CISPR quasi-peak (Peak) detection mode.

Measurements were taken using both HORIZONTAL and VERTICAL antenna polarization, herein referred to as H and V, respectively.

Field Strength Calculation

The Field Strength (FS) is calculated by adding the Antenna Factor (AF) and Cable Factor (CF) and Amplifier Gain(AG) from the Measured Reading (MR). The basic equation with a sample calculation is as follows:

$$\text{* Below 1 GHz : FS(dB}\mu\text{V/m)} = \text{MR(dB}\mu\text{V)} + [\text{AF(dB/m)} + \text{CF(dB)}]$$

$$\text{* Above 1 GHz : FS(dB}\mu\text{V/m)} = \text{MR(dB}\mu\text{V)} + [\text{AF(dB/m)} + \text{CF(dB)}] - \text{AG}$$

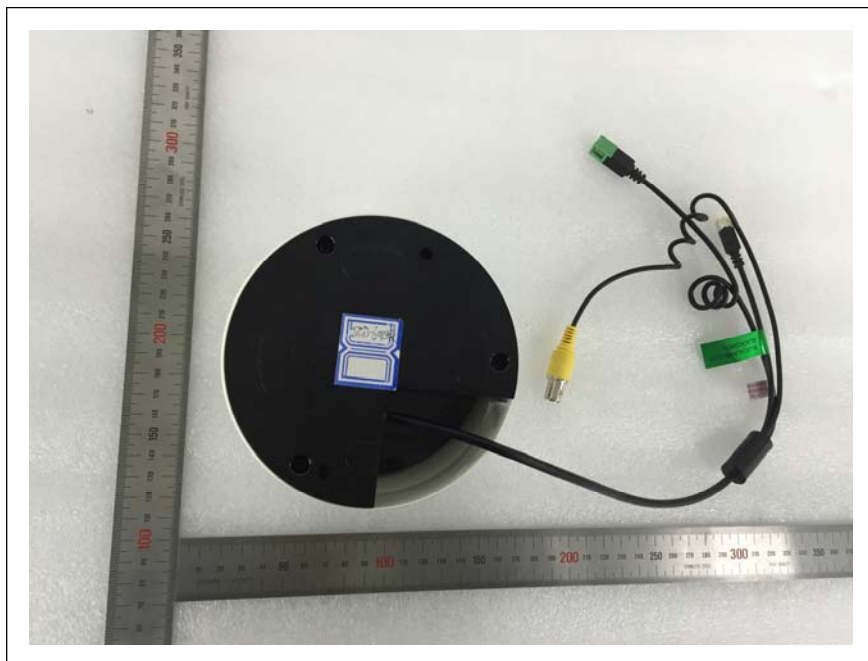

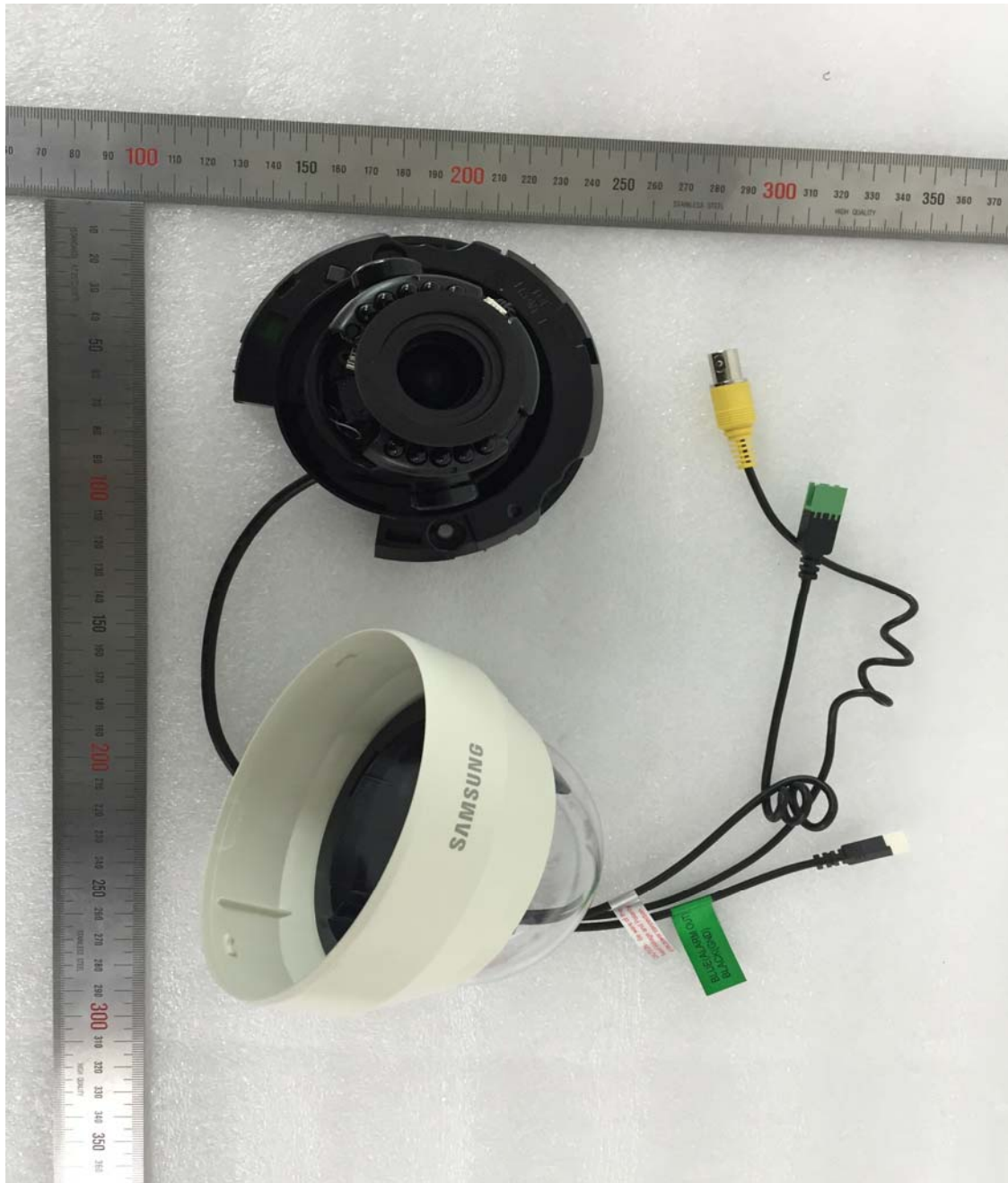

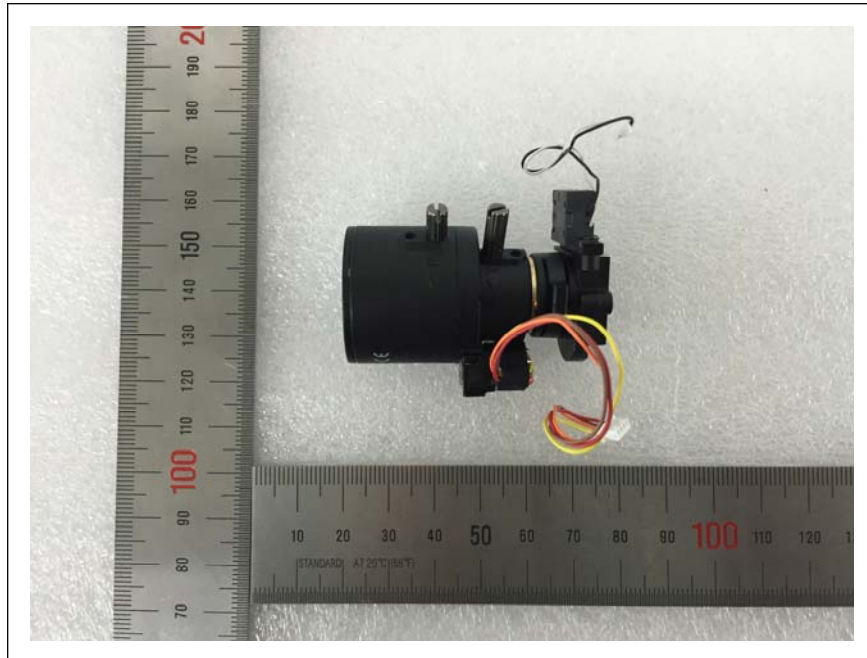
E.U.T: Internal View(Top) - IR Board



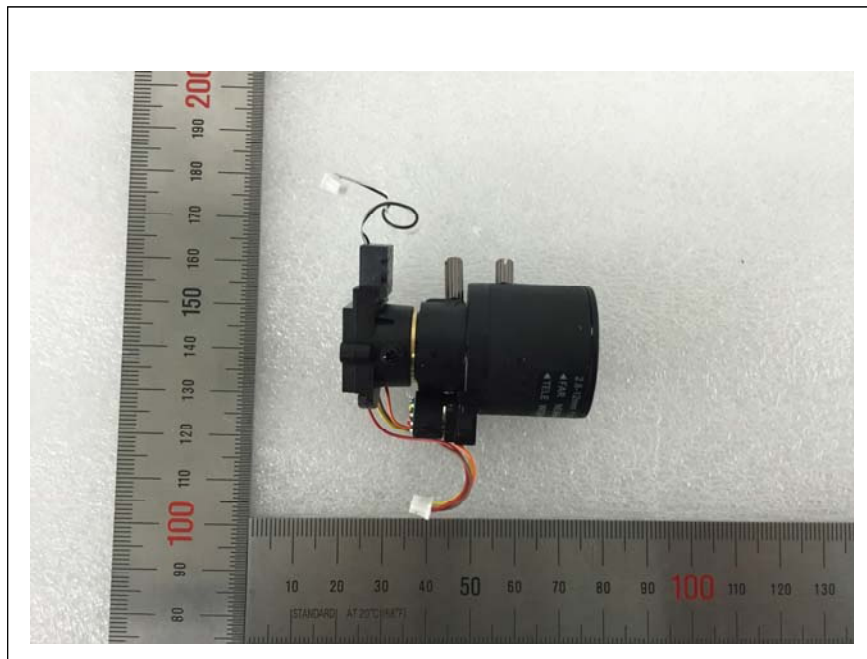
E.U.T: Internal View(Bottom) - IR Board

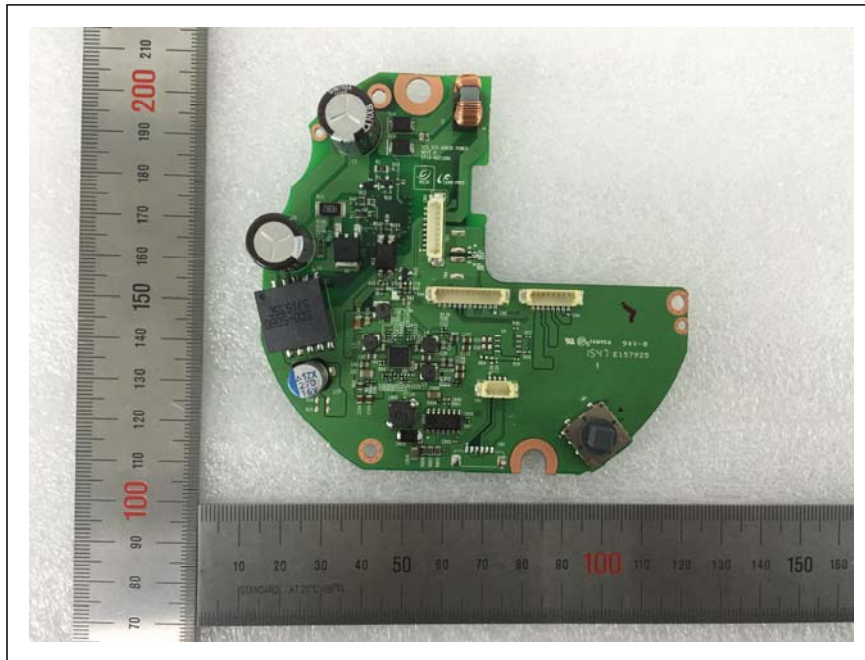

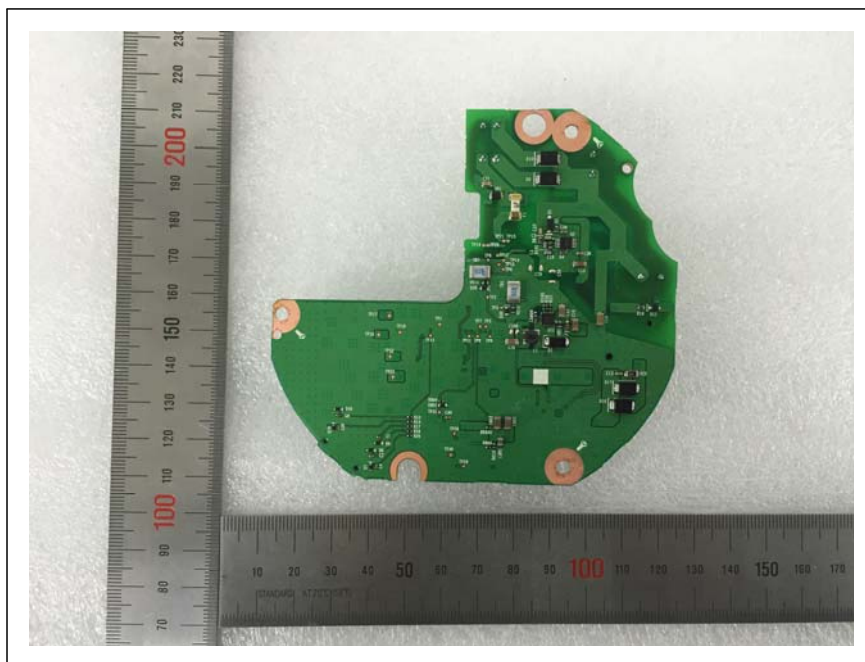

E.U.T: Internal View(Top) - Main Board

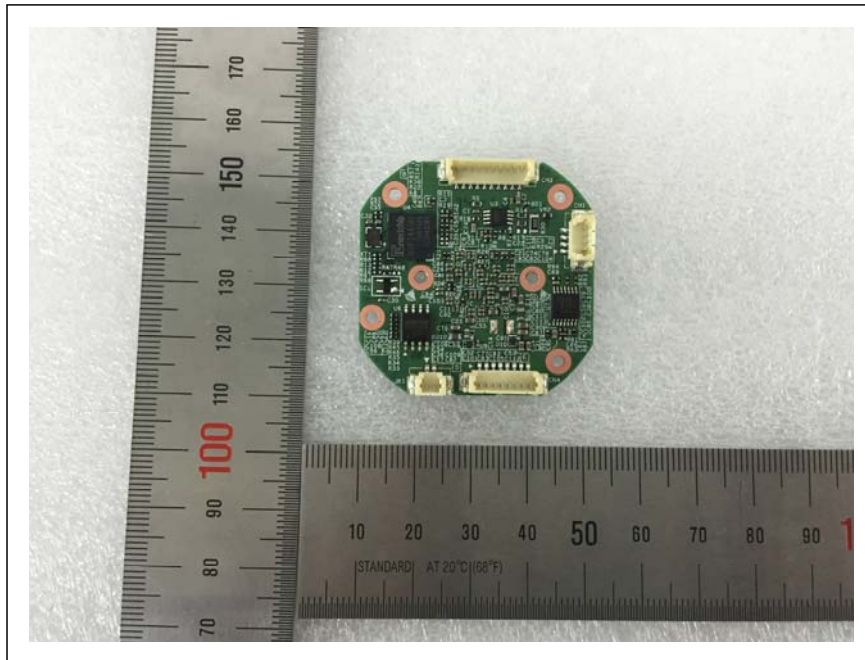


E.U.T: Internal View(Bottom) - Main Board

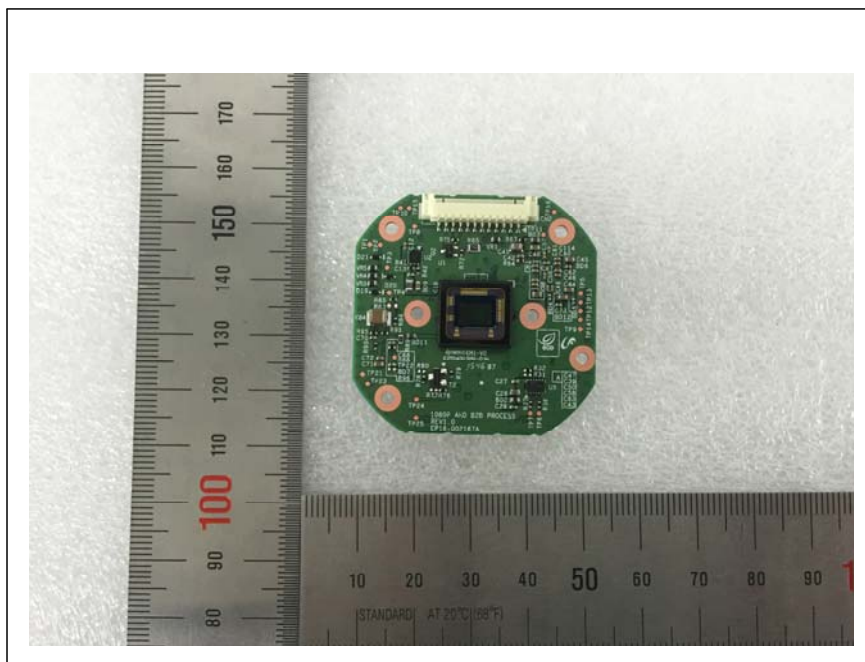
