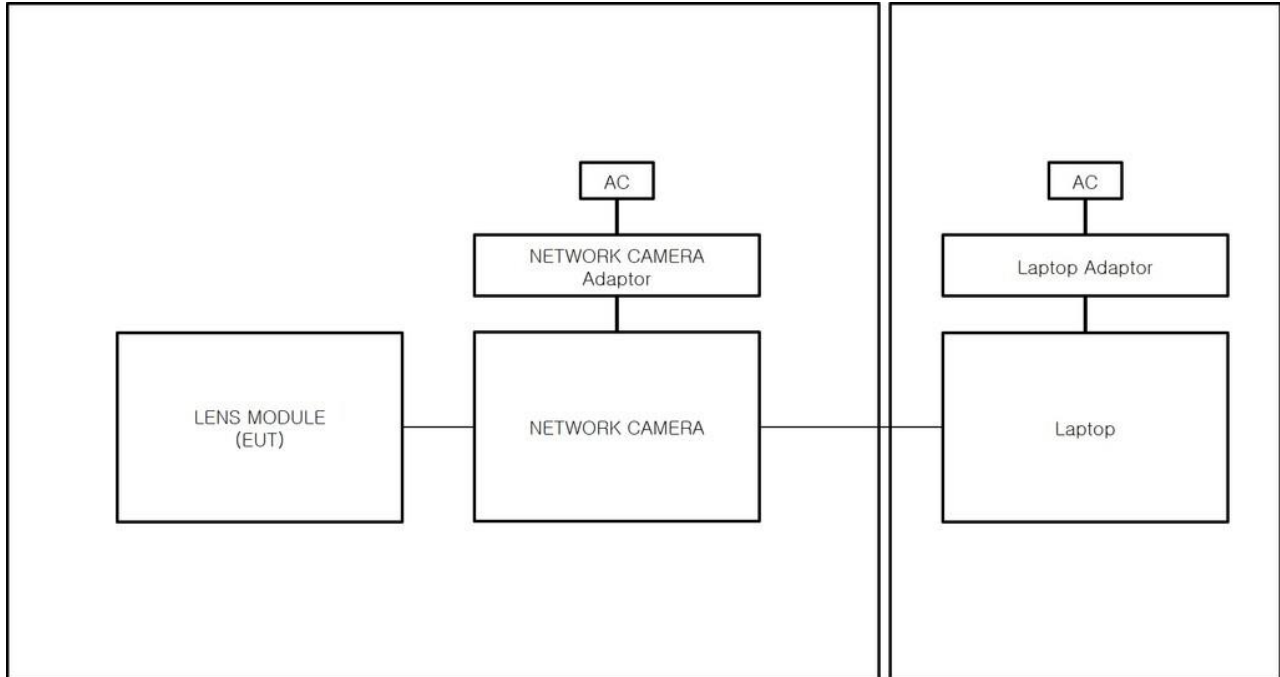

5 Measurement Procedure

- Conducted Emissions

The conducted emission levels were measured on each current-carrying line with the spectrum analyzer operating in the CISPR quasi-peak mode (or peak mode if applicable). The initial step in collecting conducted data is a spectrum analyzer peak scan of the measurement range. If the conducted emission exceed the average limit with the instrument set to the quasi-peak mode, the measurements are made in the average mode. The emission spectrum was scanned from 150 kHz to 30 MHz. The highest emission amplitudes relative to the appropriate limits were measured and have been recorded. Quasi-peak readings are distinguished with a "QP".

- Radiated Electric Field Emissions

The test was done at a SEMI ANECHOIC CHAMBER with quasi-peak detector. The final test data was measured using a Quasi-Peak detector below 1 GHz at 10 m or 3 m distance and a Peak and Average detector above 1 GHz at 3 m distance. Test was proceeded worst case test mode and cable configuration. Measurements were made with the antenna positioned in both the horizontal and vertical planes of polarization. The antenna height was varied from 1 m to 4 m (Radiated Emissions(Below 1 GHz)) and 1 m (Radiated Emissions(Above 1 GHz)) and the EUT was rotated 360° to find the maximum emitting point for each frequency.

Measurement procedures was In accordance with ANSI C63.4 or CISPR 32.

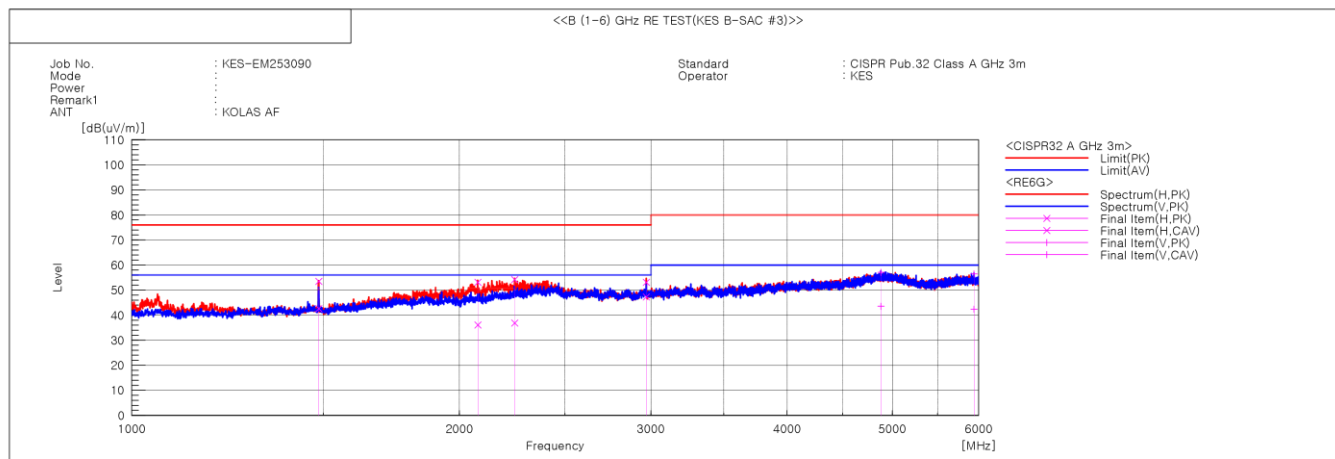

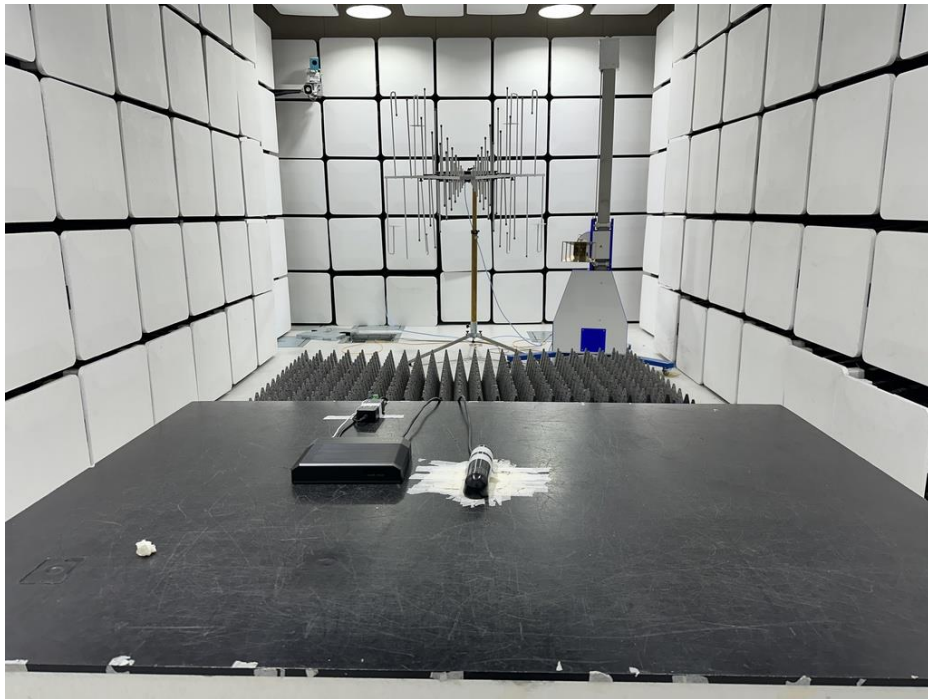
