ОСНОВНЫЕ ХАРАКТЕРИСТИКИ

С помощью контроллера системы SPC-6000 можно управлять внешними устройствами (камерами PTZ, цифровыми видеомагнитофонами, MATRIX) по стандарту RS-485. Контроллер имеет понятный интерфейс с экранными меню, сенсорный экран и джойстик.

- Пульт дистанционного управления дальнего действия
- При использовании стандарта RS-485 можно управлять устройствами, расположенными на расстоянии до 1 км.
- Встроенное управление системой
- С помощью одного контроллера системы можно управлять всеми камерами (ресиверами), цифровыми видеомагнитофонами, MATRIX.
- Одновременное подключение нескольких контроллеров системы
- Можно подключить одновременно до 16 контроллеров и управлять системой из разных мест.
- Возможность перемещения джойстика и поворотного манипулятора (jog-shuttle)

МЕРЫ ПРЕДОСТОРОЖНОСТИ

Прежде чем приступить к установке, прочитайте и примите к сведению следующие инструкции.

- Контроллер предназначен для использования внутри помещения.
 - Оберегайте его от воздействия влаги и прямого попадания воды.
 - Не подвергайте его агрессивному физическому воздействию.
 - Не тяните за кабель питания с чрезмерным усилием.
 - Не разбирайте контроллер самостоятельно.
 - Используйте только рекомендованный диапазон ввода-вывода.
 - Используйте только прилагаемый кабель питания.
 - По возможности используйте кабель питания с заземляющим проводом.
 - Для установки контроллера системы найдите ровную поверхность.
 - Правильное расположение основного устройства и проводки очень важно для нормальной работы системы.
 - Если расположить контроллеры слишком близко друг к другу или поместить в плохо проветриваемую среду, может нарушиться работа системы.
Если доступ к системе затруднен, могут возникнуть проблемы с ее ремонтом.
 - Чтобы избежать поломки системы и сократить время простоя, оставьте достаточно места для нормальной вентиляции и плотно закрывайте крышки устройств.
 - Не разбирайте контроллер системы самостоятельно, поскольку его детали находятся под высоким напряжением.
- Рабочая температура: 0°C ~ 40°C
 - Температура хранения: -20°C ~ 60°C
 - Рабочая влажность: 10% ~ 70% (относительная)
 - Влажность при хранении: 10% ~ 90% (относительная)

ПЕРЕД УСТАНОВКОЙ

- Перед установкой необходимо выключить контроллер.
- Сильный удар или вибрация могут привести к поломке системы.
- Не оставляйте контроллер в зоне действия сильного магнитного поля, электрических помех или беспроводных устройств, таких как радиоприемник или телевизор.
- Следите за тем, чтобы место установки всегда оставалось чистым и незапыленным, пока там находится контроллер.
- Контроллер следует установить на ровную поверхность в легкодоступном месте с подходящей температурой. Между контроллером и стеной нужно оставить расстояние не менее 15 см.
- Не накрывайте вентиляционное отверстие и не допускайте попадания в него токопроводящих предметов.
- Не подвергайте контроллер воздействию прямых солнечных лучей. Храните принадлежности и инструменты в недоступном для посторонних месте, чтобы избежать травм.
- Появление дыма или странного запаха сигнализирует об опасности воспламенения или поражения электрическим током.
В этом случае немедленно отключите контроллер и обратитесь в Samsung за технической поддержкой.
- Примите немедленные меры, если на поверхности будет разлита жидкость, вы увидите незаземленный удлинительный кабель питания или кабель с поврежденной изоляцией, заметите отсутствие защитного заземления.



- Протрите поверхность контроллера сухой тканью. Для удаления стойких загрязнений или пятен используйте нейтральные моющие средства.
Не используйте летучие растворители, такие как спирт, бензол и разбавитель, так как они могут повредить поверхность.
- Не включайте ЖК-монитор при высокой температуре воздуха. В целях экономии электроэнергии рекомендуется использовать экранную заставку.

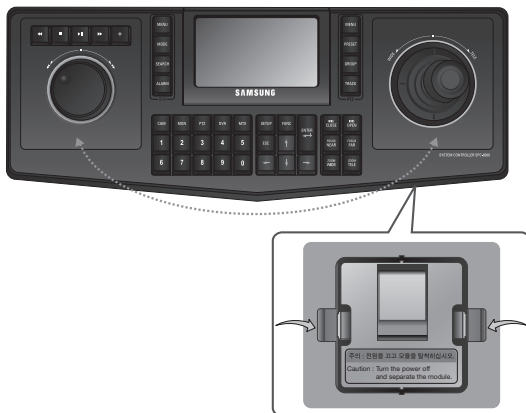

ПЕРЕМЕЩЕНИЕ ДЖОЙСТИКА И ПОВОРОТНОГО МАНИПУЛЯТОРА

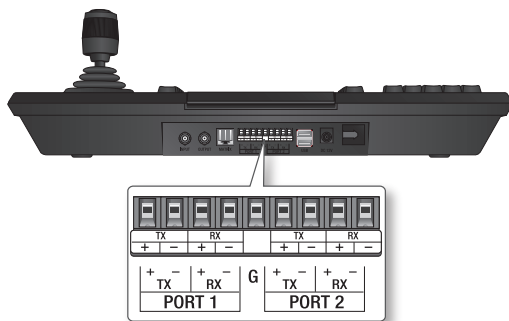

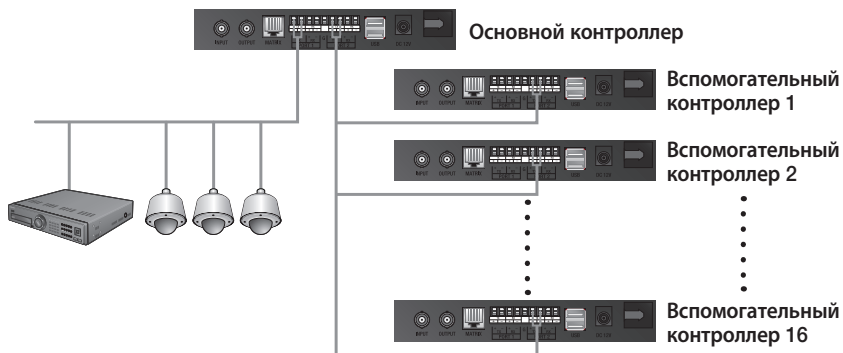

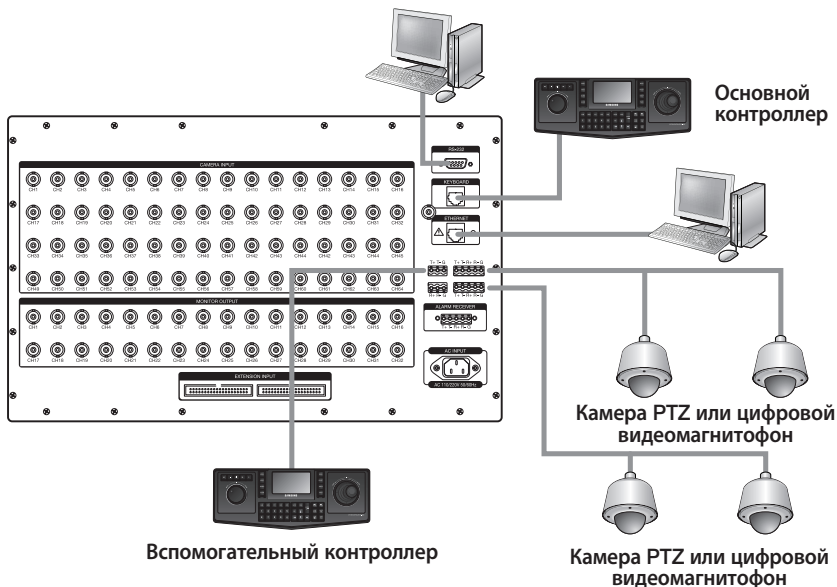

The GNU General Public License is a free, copyleft

11. Patents.

Preamble

The licenses for most software are designed to take away your freedom to share and change it. By contrast, the GNU General Public Licenses are intended to guarantee your freedom to share and change free software to make sure the software is free for all its users.

This license, the Lesser General Public License, applies to some specially designated software packages—typically libraries—of the Free Software Foundation and other authors who decide to use it. You can use it too, but we suggest you first think carefully about whether this license or the ordinary General Public License is the better strategy to use in any particular case, based on the explanations below.

When we speak of free software, we are referring to freedom of use, not price. Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software (and charge for this service if you wish); that you receive source code or can get it if you want it; that you can change the software and use pieces of it in new free programs; and that you are informed that you can do these things.

To protect your rights, we need to make restrictions that forbid distributors to deny you these rights or to ask you to surrender these rights. These restrictions translate to certain responsibilities for you if you distribute copies of the library or if you modify it.

For example, if you distribute copies of the library, whether gratis or for a fee, you must give the recipients all the rights that we gave you.
