- Instalación directa en pared/techo



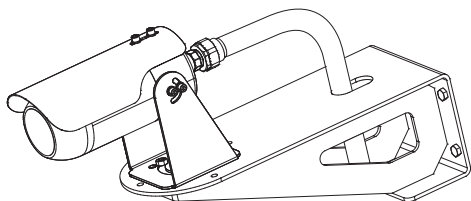

## CONFIGURACIÓN DE CONTRASEÑA

Al acceder al producto por primera vez, debe registrar la contraseña de inicio de sesión.
