- Installation du câble réseau (IP66)

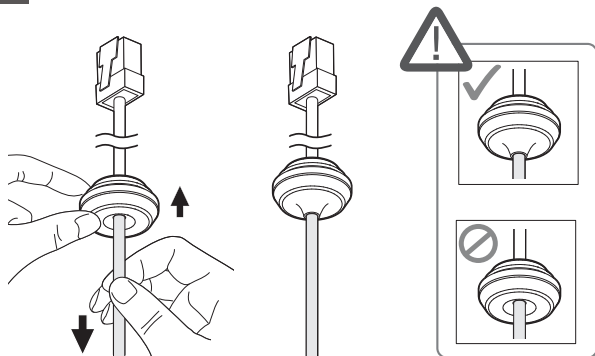
