УСТАНОВКА ПАРОЛЯ

Когда доступ к продукту выполняется первый раз, необходимо зарегистрировать пароль входа в систему.



- Если новый пароль имеет длину 8 или 9 символов, вы должны использовать минимум 3 типа символов из перечисленных: заглавные латинские буквы, строчные латинские буквы, цифры и спецсимволы. Для пароля длиной 10 символов и больше достаточно использовать 2 типа символов из перечисленных. (максимум символов — 64)
- Допускаются следующие специальные символы :
~!@#%&*{} _-+=[]\|;:'",<>.,?/
- В пароле пробелы использовать нельзя.
- Пароль и идентификатор должны быть разными.
- Для большей безопасности нельзя использовать в качестве пароля ряд повторяющихся символов или символов, расположенных на клавиатуре друг за другом.
- Обязательно запомните заданный пароль — в случае его утери потребуется сбросить устройство с помощью кнопки **[RESET]**.

ВХОД

- ❶ Введите "admin" в поле ввода <User Name>.
- ❷ Введите пароль в поле ввода <Password>.
- ❸ Нажмите кнопку [Sign in].

Настройка камеры

- ❶ Подключите переходник OTG (Type C) и адаптер Wi-Fi к порту USB Type C.

Настройка смартфона

- ❶ Установите приложение для установки Wisenet.
- ❷ После соединения с WiFi выберите SSID камеры.
- ❸ Запустите приложение установки Wisenet.
- ❹ После входа в систему камеры будет подключено видео.
- ❺ Угол обзора камеры можно регулировать во время просмотра видео на смартфоне.
